follows :-

① That I have lodged a written complaint before the Inspector-in-charge, Bhaktinagar Police Station on 04/04/22 against  
① Dilip Singh, ② Prakash Singh, both S/O - Unknown, both are  
resident of Prakash Nagar, S.M.C. Ward No. 43, Siliguri -  
734001 and their 10/12 unknown miscreants.

② That on the basis of the said complaint your P.S. started  
investigation in the said matter.

③ That said Dilip Singh and Prakash Singh somehow  
came to know about my above noted written complaint.

④ That thereafter today at about 2:30 P.M. said Dilip  
Singh, Prakash Singh and one Dinesh Prasad Singh @  
Dinesh Master, S/O - dt. Basudev Singh, resident of Prakash  
Nagar, S.M.C. Ward No. 43, P.S. - Bhaktinagar, Siliguri -  
734001 along with 15/20 unknown miscreants came  
to land and started to break the boundary wall of  
my land and I along with my son Amit Kumar Yadav  
rushed to the spot and protested against their illegal  
work and then suddenly they started assaulting  
me and my son.



⑤ That the suddenly said Prakash Singh took a iron-rod and hit in the head of my son with intend to murder him and my son fell down and fainted and seeing this I, along with my wife Smt. Manju Devi and my aunty Smt. Kalawati Devi rushed to rescue my son, then said Dilip Singh and Dinesh Prasad Singh @ Dinesh Master along with 10/15 unknow miscreants started to assaulting us with Lathi, Bamboo, rods etc and Dilip Singh tore the saree of my wife and said Dinesh Prasad Singh @ Dinesh Master tore the saree of my aunty and both of them touched my wife and aunty in indecent manner with intend to outrage them modesty by forcefully.

⑥ That thereafter local people gathered and chased them and all of them fled away from the spot.

⑦ That my son sustained severe injuries in head with few stitches and admitted in North Bengal Medical College & Hospital, Sushrotanagar, P.S. - Matigara and my aunty sustained injuries in her hands.

⑧ That all the accused persons are land-grabber of the locality.

Under the above circumstances it is my humble request before you to investigate the matter and to take appropriate legal-action against said ① Dilip Singh, ② Prakash Singh, ③ Dinesh Prasad Singh @ Dinesh Master and 10/15 unknown miscreants as they tried to murder my son, assaulted us and outraged the modesty of my wife and aunty forcefully.
