With due respect I, **SONI SINGH**, Wife of Sri Prakash Kumar, resident of Prakash Nagar, S.M.C Ward No. 43, P.O Sevoke Road, P.S Bhaktinagar, Dist Jalpaiguri (WB) begs to state that today at about 1.30 P.M while my husband was coming to our place of residence and near Nissan Showroom, Prakash Nagar, Under Bhaktinagar Police Station my husband saw Sudish Yadav S/O Not Known along with his other family members and some antisocial persons making an attempt to demarcate the land which was/is purchased by our family members. That seeing the same my husband asked them why they are making such illegal activity. That Mr. Sudish Yadav, his son and some antisocial persons attacked upon my husband with iron rod and sharp weapon. That my husband sustained bleeding injury in his head and his right leg got fractured. That somehow my husband escaped from the hand of the aforesaid person otherwise their intention was to kill my husband. That after getting the knowledge about the said incident I rushed to our aforesaid plot of land and the aforesaid persons after seeing me became violent and started quarreling with me and they tried lay hands upon me trying to outrage my modesty. That I left the place and I found my husband was in serious condition lying 100 meter far from the place of occurrence and I took my husband to Government Hospital, Siliguri and seeing the condition of my husband the duty doctor referred him to N.B.M.C & H for better treatment. That we took my husband to N.B.M.C & H but the duty officer advised us to take him to Kolkata. That my husband condition is very serious condition due to their merciless assault. That they are very desperate in nature and there is every possibility that they will take the laws in their hands.

So, I therefore request before you to kindly look into the matter and start specific case against the above named accused person. I shall be highly obliged for this act of kindness.
