Respected Sir,

I, Chanda Mallick, D/o. Raghunath Mallick, wife of Shyambir Singh, R/o. Lichu Bagan, Near Durga Mandir, P.O. & P.S. Bagdogra, District Darjeeling West Bengal, India, would like to state that on 15-03-2022 at about 7.00 P.M. when I went out of my to attend a Party at my friends home near Pioneer Ground suddenly two persons namely (1) Sunny Mahato & (2) Upender Mahato, both sons of Kameshwar Mahato, R/o. Lichu Bagan, Near Durga Mandir, P.O. & P.S. Bagdogra, District Darjeeling West Bengal, India, catch hold of me and after physically assaulting me snatched my mangalsutra from my neck. They physically assaulted me due to which I sustained injury in my back. Thereafter the very next day i.e. on 16-03-2022 I went to their house and requested them to return my mangalsutra but they said that they will return me my mangalsutra after some days as the mangalsutra was kept with their mother who went to Bihar and will return after 20 days. They also requested me not to lodge any case as they will return the mangalsutra. Later on 04-04-2022 again at about 4.30 P.M. when I went to their house to take my mangalsutra back (1) Sunny Mahato (2) Upender Mahato, (3) Kameshwar Mahato, (4) Smt. Mina Devi Mahato, (5) Smt. Basanti Mahato, (6) Smt Kajal Mahato called me inside their house premises and physically assaulted me. As I was alone I could not resist them. Due to god's grace I anyhow managed to get rid of their hand. I was not in a position to lodge the FIR yesterday as I was shocked and was in trauma.

It is requested before you in folded hand to kindly take strict necessary action against the abovenamed miscreant so that my mangalsutra can be recovered and they can be punished for their illegal acts.
