Sir,

I, Goutam Deb (son of Late Tejendra Binod Deb), resident of College Para, Ward No: 17 of Siliguri Municipal Corporation, P.O. & P.S. Siliguri, District Darjeeling, PIN - 734001, presently holding the office of Mayor, Siliguri Municipal Corporation, wish to hereby lodge this complaint with you in respect of a video bearing the link <https://youtu.be/gxxmbqTIDvA>. I have come across the said video which has been forwarded to me by Udayan Guha to my mobile number yesterday. I have watched the said video which appears to be in the nature of a news report with the caption: "এক দিনে দুই পাখি ভারত হিট, গুজু, ওভিসেবের পর উদয়ন ও গোবিন্দ দেব, কমলা ও গুরু সাহায়ে কলকাতা উদয়ন ও গোবিন্দ কে হেঁচকে হিট, খোলা শেষ।"

Thereafter, the author of the said video stated that within two/three days Goutam Deb and Udayan Guha will be served with the notices of the Enforcement Directorate in connection with coal and cow smuggling cases. The said video displays the logos of "YouTube" and "The Bengal Bugle". The said video which is available on "YouTube" to which lakhs of people have access to view. The maker/author of the said video has made false, baseless, cooked up, misleading and fake story converted in the form of news containing allegations as stated above and circulated the same on internet through YouTube deliberately with an ulterior motive and mala fide intention to malign me and to harm my reputation and honesty in the eyes of numerous people of the State and the country and thus defame me in the society at large. The said video has been deliberately made and circulated with the oblique and ulterior motive of lowering me in the estimation of my well-wishers, friends, family members, colleagues at my place of work and elsewhere and the members and supporters of All India Trinamool Congress.

The aforesaid illegal acts of the maker/author of the said video is against the provisions of the Information Technology Act and is liable to be prosecuted. In the above circumstances, I, most humbly request you to kindly inquire into the matter immediately and to take appropriate legal action against the perpetrators of the offence as aforesaid. The delay in lodging this complaint due to my official engagements may kindly be condoned.
