I, Pawan Sharma, S/o Late Ram Kishan Sharma, residence of Hemkunt Apartment, Flat No. D2, Gurunanak Sarani, Punjabi Para, Siliguri would like to lodge this complaint before you on the fact that on 6th of April 2022 at about 12.50 P.M. I got one whatsapp message which was forwarded to me by my relative whose telephone no. is 9851380808 than I saw the message and noticed that it was fake message, intentionally forwarded and created by some unknown person or agencies labeling false , vague allegation against my elder brother Vinod Sharma, accusing him in false charge of rape, and they provoked persons to kill my brother. Thereafter I got phone calls from many persons who were asking me about the incident as they also get forwarded the same message , one of such phone number of those of my nearest person who got the same message is 9851453445. It is also very heart broken incident happened when the class teacher of my niece from Narayan School, Siliguri Branch informed me that they also got such type of vulgar and fake messages from those persons or agencies. It is also be informed that thereafter some of my known persons informed me that they also got some messages from one Rupee Star App and name & phone number of those persons who got the messages are 1. Priyank Singh (9832403334), 2. Amit Dubey (9800621888). The letter message which was forwarded to ask is in the following manner that my brother Vinod Sharma took a loan of Rs. 8297/- (Rupees Eight Thousand Two hundred Ninety Seven) from there app namely Rupee Star and they also threatened that if we did not take action than they will take actions against us. Today my Brother-in-Law also received a call from some unknown person whose Cell phone number is 7908547960 who also enquired where abouts of my brother Vinod Sharma and also threatened that if money was not paid to them they will kill my brother within next 48 hours. Now in this situation me and my family are facing

tremendous mental pressure, agony and fear that at any moment any illegal action may be taken against us by those miscreants who are trying to extort money from us and my brother also for their illegal gain. By circulating this message they are destroying our social reputation for their illegal motive. Now me and my family members are scared that I may lose my brothers life any time, we are really facing hell.

In this circumstances it is my humble submission before you that you please be kind enough to take proper legal action against those unknown miscreants who are trying to circulate those fake, vulgar, false messages against my brother with a illegal intension to extort money from us by using such illegal means and obliged.
