In producing herewith (04) four arrested accused persons namely 1] Situ Roy (19) s/o Naresh Roy of Dada Bhai Colony, Near Durga Mandir, PS Bhaktinagar, Dist. Jalpaiguri 2] Nanda Lal Paswan (22) s/o Baban Paswan of Paswas Busty, Near Hanuman Mandir, PS Bhaktinagar, Dist Jalpaiguri 3] Dipak Biswas (21) s/o Late Lal Mohan Biswas of Janata Nagar, Hilmanshu More, PS Bhaktinagar, Dist. Jalpaiguri 4] Putau Roy (21) s/o Kukil Roy of Vidhyachakra Colony, Near Ganga Mandir, PS Bhaktinagar, Dist. Jalpaiguri and others along with following seized articles viz :-

1. One iron made knife fitted with wooden handle measuring length 36 cm (approx) seized from the possession of accused Situ Roy.
2. One iron rod measuring about 62 cm (approx) seized from the possession of accused Nanda Lal Paswan.
3. One iron rod measuring about 41 cm (approx) seized from the possession of accused Dipak Biswas.
4. One iron hacksaw fitted with wooden blade measuring 47 cm (approx) from the possession of Putau Roy.

I, PSI Sailesh Subba of Bhaktinagar Police Station under Siliguri Police Commissionerate do hereby lodge this suo-moto complaint against the above noted accused persons to the effect that, on 04.04.2022 at about 23.35 Hrs received a source information that some 7 to 8 youths have assembled at Bhanunagar, Behind Sai Hospital, under Bhaktinagar PS, SPC making preparation to commit crime at that area. Accordingly the information was intimated to I/C Bhaktinagar PS and noted the fact in G.D vide Bhaktinagar PS GDE No-226, Dated 04.04.2022 and as per his direction, myself along with, ASI Dipak Karmakar, ASI Rabin Lama, C/374 Debraj Biswas, C/762 Mujibul Rahaman, CVF/935 Biplab Roy, CVF/619 Dharmendra Roy, CVF/014 Labannomoy Barman left PS to work out the information. Inform night mobile van officer SI Dwipendra nath Bakshi and requested him to accompany the raid team. At 23.45 hrs I along with force reached at BhanuNagar and as shown by the source we subsequently cordoned off the place and suspected persons with a strong reason to believe that they were preparing to commit some cognizable offence. Sensing the police had cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 04 (Four) accused persons along with seized articles as mentioned above and detained all of them. However, the other persons managed to fled away from the spot taking the advantage of darkness. On interrogation the apprehended accused persons admitted that they had assembled there to commit dacoity at one of the house at Bhaktinagar PS area. They also stated that other persons fled away from the spot.

I accordingly brought the arrested accused persons along with seized article at Bhaktinagar Police Station for further investigation. During interrogation, they stated that they assembled there to commit dacoity in a house at Bhaktinagar PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons] Situ Roy (19) s/o Naresh Roy of Dada Bhai Colony, Near Durga Mandir, PS Bhaktinagar, Dist. Jalpaiguri 2] Nanda Lal Paswan (22) s/o Baban Paswan of Paswas Busty, Near Hanuman Mandir, PS Bhaktinagar, Dist Jalpaiguri 3] Dipak Biswas (21) s/o Late Lal Mohan Biswas of Janata Nagar, Himanshu More, PS Bhaktinagar, Dist. Jalpaiguri 4] Putau Roy (21) s/o Kukil Roy of Vidhyachakra Colony, Near Ganga Mandir, PS Bhaktinagar, Dist. Jalpaiguri and other associates and arrange for its investigation.
