With due respect I, **SAIRA BIBI**, W/O Md. Shaful Ansari, resident of Prakash Nagar, Ward No. 43 of S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal - 734001 begs to state that I am a widow. That 1) Sudish Yadav S/O Baccha Yadav, 2) Amit Yadav Son of Sudish Yadav, 3) Neha Yadav D/o Sudish yadav all are resident of Prakash Nagar, Ward No. 43 of S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal - 734001 along with their other family members and some antisocial persons came to my place of residence on 21.02.2022 at around 10:00 am and started assaulting me with fist, blows and sharp weapons and I sustained severe injuries. That they started threatening me stating that they shall kill me if the land I possess is sold out to anyone else and if I went before any Police authorities. Due to such threatening I found no alternative and sold out my land to Dilip Kumar Singh, S/O Ram Sewak Singh, resident of Prakash Nagar, S.M.C Ward No. 43, P.O Sevoke Road, P.S Bhaktinagar, Dist Jalpaiguri (WB) and ran away from my residence to my relatives house at Malda to save my life. I obtained some treatment there with the help of my relatives and well wishers. I could not lodge a complaint before any police authorities as because they had threatened me that they shall kill me if I go to any police authorities. Moreover I was undergoing treatment at Malda with my relatives so I could not go before the Police authorities to lodge a complaint against the aforesaid persons. That the above named persons are desperate in nature and there is every possibility that they shall take the law in their hands and can do anything to harm me. That they demolished the structure and taken away all the valuable items from my aforesaid house in my absence.

So I therefore request before you to kindly look into the matter and do the needful to start a specific case against the aforesaid persons under the provisions of law.


