In producing herewith two accused persons namely 1] Jogendra Nath Chettri @ Yogesh (32) s/o Kuldeo Chettri of Champasari More, Near Gramin Bank, PS Pradhan Nagar, Dist. Jalpaiguri 2] Dipankar Karmakar (31) s/o Dilip Karmakar of Bhagajatin Colony, Gali No.45/9, PS Pradhan Nagar, Dist. Darjeeling and 3] Babu Kar @ Bapi (35) s/o Goutam kar of Kaltex More, Near Pragati Sangha, Bazaar Road, PS Mal bazaar, Dist. Jalpaiguri under custody and the following seized articles viz:

1] Fifty (50) Bottles of Rx REXLEY Cough Syrup composition of Chlorpheniramine Maleate IP 4 mg. & Codeine Phosphate IP 10mg, manufactured by Mancare Laboratories Pvt. Ltd. (An ISO 9001:2015 & GMP Certified Company) Plot No.11, Pharmacy, Selaqui, Dehradun, Uttarkhand-248011, each Bottle containing 100 ml (Total 50 X 100 ml = 5000 ml = 5Litres) packed, sealed and marked as "Exhibit-A".

2] Seventeen (17) Strips of NRx Pyeevon Spas Plus composition of Dicyclomine Hydrochloride 10mg, Tramadol Hydrochloride 50mg, Acetaminophine 325mg, manufactured in India by Laborate Pharmaceuticals India Pvt. Ltd. (Unit-II)#31, Rajban Road, Narinwala, Paonta Sahib(H.P) each strips containing 08 pieces of capsules (Total 17 X 08 = 136 pieces of capsules) packed, sealed and marked as "Exhibit-B"

3] Twenty One (21) Strips of NRx Nitrosan 10 composition of Nitrazepam IP 10mg, manufactured in India by san Pharmaceutical Ind. Ltd. Industrial Area -, A.B Road, Dewas (M.P) 455001, each strips containing 10 pieces of capsules (Total 21 X 10 = 210 Pieces of capsules) packed, sealed and marked as "Exhibit-C"

4] One multicolour polythene Hand Bag written over Brahmputra Cracker, Brahma Lene, (Gail India) Limited (in which all the above noted seized articles were kept inside it.) marked as "Exhibit- D".

5] One White Colour Screen touch Oppo Brand mobile Phone bearing IMEI 1: 861014056306797 and IMEI 2: 861014056306789 seized from the possession of Dipankar Karmakar.

6] One Light Green Colour screen touch Realme Brand mobile Phone bearing IMEI: 868903058104213/06 and IMEI 2:868903058104205/06 from the possession of Babu Kar @ Bapi.

7] One Blue Colour screen touch Samsung Brand Mobile phone bearing IMEI 1:355368119609420/01 and IMEI 2: 355369119609428/01 seized from the possession of Jogendra Nath Chettri @ Yogesh.

Seized the above noted articles from the joint possession of possession of accused persons namely 1] Jogendra Nath Chettri @ Yogesh (32) s/o Kuldeo Chettri of Champasari More, Near Gramin Bank, PS Pradhan Nagar, Dist. Jalpaiguri 2] Dipankar Karmakar (31) s/o Dilip Karmakar of Bhagajatin Colony, Gali No.45/9, PS Pradhan Nagar, Dist. Darjeeling and 3] Babu Kar @ Bapi (35) s/o Goutam kar of Kaltex More, Near Pragati Sangha, Bazaar Road, PS Mal bazaar, Dist. Jalpaiguri.

I, PSI Suresh Subba s/o Mahendra Subba of Bhaktinagar Police Station under Siliguri Police Commissionerate do hereby lodge this suo-moto complaint to the effect that on 07.04.2022 at around 22:35 Hrs I, received a secret source information that three notorious drug peddlers namely Jogendra Nath Chettri of Champasari and two others persons has procured huge quantity of Cough Syrup and capsules inside one white colour Hand-bag, from Champasari area and are standing at Gandhi Maidan, Prakash Nagar under Bhaktinagar PS for disposing it clandestinely for their wrong ful gain. And if acted immediately they may be caught red handed at the noted area. Accordingly I, diarized the matter vide Bhaktinagar PS GDE No. 297, Date. 07.04.2022 and informed before you Inspector Incharge of Bhaktinagar PS. And as per your kind order at about 22.45 Hrs I along with ASI Rabin Lama, ASI Dipak Karmakar, C/762 Mujibul Rahaman, C/376 Debraj Biswas, CVF/ Sumit Roy all of Bhaktinagar PS left

from PS to verify the veracity of the information. Before leaving PS I took seal, envelope, and other investigation kits. This refers to Bhaktinagar PS GDE No. 298, Dated 07.04.2022 and MCC No. 862/22, Dated. 07.04.2022. On the way towards Gandhi maidan I, briefed the whole team about the information and organize a plan for its execution.

At around 22.55 Hrs I accompanied with the whole team and along with two independent witnesses arrived at Gandhi Maidan and parked the vehicle at considerable place and started moving towards the spot as shown and identified by my source. On the way I called two disinterest witnesses namely namely 1] Md. Habib (33) s/o Late Md. Hadish of Ashraf nagar, Near Masjid, Ward No. 40, PS Bhaktinagar, Dist. Jalpaiguri 2] Md. Pappu (25) s/o Md. Mustakin of Ashrafnagar, Near Masjid, PS Bhaktinagar, Dist. Jalpaiguri and informed them about the information in written and requested them to accompany with us as witness during search and seizure if necessary. And they agreed to accompany us during the whole period of raid. Further, I arrange all the accompanied team to cordon the identified persons from all sides to prevent them from escaping. Accordingly I, along with my accompanied team started approaching towards the accused persons as identified by my source. Far from the distance in presence of faint rays of street light I, saw three persons standing at the north- west corner of Gandhi Maidan and saw one white colour bag holding by two persons and one person was talking over the mobile phone. This leads to strong reason to believe that they have possessed some contraband articles and came at Gandhi Maidan to deliver the same to their designed customers. Accordingly I along with accompanied team managed to intercept all of the three persons and detained all of them and the bag from the possession of Dipankar Karmakar and Babu Kar @ Bapi.

Further, I, produced my identity card and introduced myself as a Police officer to the detained accused persons and the accompanying team as police personal. On being asked about their name and address they disclosed their identity as 1] Jogendra Nath Chettri @ Yogesh (32) s/o Kuldeo Chettri of Champasari More, Near Gramin Bank, PS Pradhan Nagar, Dist. Jalpaiguri 2] Dipankar Karmakar (31) s/o Dilip Karmakar of Bhagajatin Colony, Gali No.45/9, PS Pradhan Nagar, Dist. Darjeeling and 3] Babu Kar @ Bapi (35) s/o Goutam Kar of Kaltex More, Near Pragati Sangha, Bazaar Road, PS Mal bazaar, Dist. Jalpaiguri. Further on being asked about the content of the bag which they were possessing. They denied to reveal the content of the bag instead they make some fabricated story to deceive the Police team. Further, on grilling them, they revealed that they have possessed Cough syrup and capsules inside the bag for delivering the same to their designed customers. I, asked them in written whether they have any objection to be searched the content of the bag in presence of any Executive Magistrate or Gazetted Officer and in return they agreed to be searched in presence of any Gazetted Officer. I, served him a notice in accordance with the provisions of law in this regard. Then at 23.15 Hrs I, apprise Shri Amaresh Singh, Inspector Incharge of Bhaktinagar Police Station, and SPC and requested him to remain present at the spot as a Gazetted Officer for search and seizure of the articles.

At 23.25 Hrs Shri Amaresh Singh, Inspector Incharge Bhaktinagar Police Station, SPC arrived at the spot and disclosed his identity as Inspector of Police as Gazetted Officer to the accused persons. At around 23.30 Hrs under the supervision of Shri Amaresh Singh, Inspector Incharge Bhaktinagar Police Station, SPC and in presence of above noted witnesses searched the detained accused persons keeping strict regard of their decency and found nothing except wearing apparel and three screen touch mobile phones from each of their pocket and on search of their bag which they were possessing found 1] Fifty (50) Bottles of Rx REXLEY Cough Syrup composition of Chlorpheniramine Maleate IP 4 mg, & Codeine Phosphate IP 10mg, 2] Seventeen (17) Strips of NRx Pyeevon Spas Plus composition of Dicyclomine Hydrochloride 10mg, Trainadol Hydrochloride 50mg, Acetaminophine 325mg, 3] Twenty One (21) Strips of NRx Nitrovan 10 composition of Nitrazepam IP 10mg, 4] One multicolour polythene Hand Bag written over Brahma Putra Cracker, Brahma Lene, (Gail India) Limited in which all the articles were kept inside it. On demand of license or documents in respect of the recovered articles they failed to produce the same. They confessed in presence of Gazetted Officer and other witnesses that they have clandestinely procured the Cough Syrup and Capsules from Champasari area for the purpose of selling to their designed customers for their wrongful gain. On interrogation all of them confessed that they have been engaged in this illegal act since long and has been importing it from different places of Siliguri and selling the same to its adjacent areas. Then as per direction of Shri Amaresh Singh, Inspector Incharge Bhaktinagar Police Station, SPC, I packed, sealed and labeled and seized all the articles as noted above in presence of witnesses under proper seizure list duly signed by the witnesses

as well as the accused persons. (The labeling and seizure was made in between 23.45 hrs and 01.05 hrs.) Then, I arrested the above noted accused persons after appraising them the ground of arrest. The copy of seizure list and memo of arrest have been supplied to the above noted accused persons. Thus, the arrested accused persons have violated the terms and conditions of N. D. P. S Act. for possessing this restricted Narcotics drugs without any legal authority.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be registered against the arrested accused person namely 1] Jogendra Nath Chettri @ Yogesh (32) s/o Kuldeo Chettri of Champasari More, Near Gramin Bank, PS Pradhan Nagar, Dist. Jalpaiguri 2] Dipankar Karmakar (31) s/o Dilip Karmakar of Bhagjatin Colony, Gali No-45/9, PS Pradhan Nagar, Dist. Darjeeling and 3] Babu Kar @ Bapi (35) s/o Goutam Kar of Kaltex More, Near Pragati Sangha, Bazaar Road, PS Mal bazaar, Dist. Jalpaiguri and arrange for its investigation.
