Sub: Attempt to murder case by few drunken residents of  
SHIVAM APARTMENT, Lenin Sarani, Near Bhrammayer Kalibari,  
Deshbandhupara.

Respected Sir,

I, Sri. Shib Shankar Saha, place the following incidents happened on 06.04.22 to me. I am a resident of Hakimpura and my son-in-law is residing at Suhasini Apartment, Lenin Sarani, Deshbandhu Para, Siliguri, Opposite of (Shivam Apartment). I came to attend the birthday ceremony of my Grand daughter with my family and other relatives.

The Car was parked in the space of 'Shivam Apartment' temporarily because of shortage of space. The space is not logically owned by Shivam Apartment but it is under SMC Siliguri.

Suddenly I heard hue and cry with abusive languages surrounding my car by a few occupants of Shivam Apartment. My son had proceeded towards the car to shift it from the place but he was badly abused. Upon my son requesting them to calm down, they started threatening and came down running to beat him. He was hurriedly beaten by 6 people and beaten severely. Upon hearing my son's voice, I along with my relatives came down running from

Second floor to rescue my son. I went in between and pleaded them to stop and spare my son. But 2 people among them grabbed me and started hurling slaps and punches at me. They pushed me to the road and started kicking and punching me. They had even dragged me on the road and had brought iron rod, knife, stones and sword to kill us. But just by then my nephew and other guests anyhow stopped them. I was bleeding from my nose, eye, legs and also received few critical wounds on my body.

During the mean time, one of them had stolen the car keys and kept it with them. Due to this, we were unable to move the car and had to go home to bring duplicate keys. My son Sumit Saha was attacked by them.

My wife and other lady guests helped in getting rescued and I was immediately taken to Siliguri Sub Divisional Hospital for treatment of profuse bleeding.

They threw abusive languages at us which cannot be expressed in black and white. I wanted the car to be moved out from that place but they did not put any ear to my request. They were in drunken state. Few of the identified people among them are -

1. Khokan Sinha
2. Gopal Sinha
3. Arjun Sinha

Other names are not known but they were family members of the above mentioned people.

The barbaric attack on me (A senior citizen) is totally unexpected. We immediately called patrolling Van of Police. They duly attended and noticed the situation.

I pray for stringent action against the attackers on such unlawful demand of the place and aggressive reaction towards me. I am being under treatment and medication. The entire incident took place at around 11 pm (06.04.22)

Your prompt action for such modus operandi of the attackers is sincerely requested.
