Sub:- Information Regarding Misbehave, Assaulting and taken away my
Furniture, Ornaments, Cash and other belongings.

Respected Sir,

I Sri. Partha Ghosh, S/O. Late Nipen Ghosh, residing at Rashbehari Sarani (By Lane), Hakimpara, Siliguri would like to state you that my wife Smt. Supriya Paul Ghosh, D/O. Swapan Kumar Paul, is living in-relation with my driver namely Sri. Santu Biswas (Bittu) residing at Hakimpara, Siliguri since last few years. When this fact is came to my notice, firstly I tried to consult with my wife and protest against this illegal relation. But they ignore me. Suddenly one day my wife left me and started to live with said Santu Biswas (Bittu) in a rented home at Siliguri. I have also consulted with my wife's family member but, after a discussion it seems to me that they also support my wife and said Bittu. After few days i.e. on 24th September 2021 they come to my home, namely my Father in law Sri. Swapan Kumar Paul, Mother in Law Smt. Bharati Paul, Brother in Law Sri. Anup Kumar Paul (Sonu), residing at J. C. Bose Road, Hakimpara, Khelaghar More, Multisweets Sweet parlour & Sri. Santu Biswas and some unknown person, they assault me and taken furniture, AC Machine Geyser etc, ornaments, Some Cash and other belongings. I opposed for the same and request them for a discussion and settlement. But they do not listen my single word, used filthy languages, and bitten me with iron rod and metal lock. Even Anup Kumar Paul tried to injure me with a kitchen used knife, but some how I rescue myself and on same day they forcefully locked my Room and Garage and keep the keys with them.

I request my wife and her parents for a healthy discussion repeatedly, with my family member, neighbor, club member of Hakimpara Paul Para Friends Union Club. But they are not agree for any discussion. Now they creating pressure to transfer the immovable property (My Flat, Garage and one Shop) which is in the name of me and my legal wife Smt. Supriya Paul Ghosh.

Recently I went to their home with a last hope with the consent of my neighbour, but they again threatening me, bitten me with filthy words.

Sir, the persons namely 1. Sri. Swapan Kumar Paul, 2. Smt. Bharati Paul, 3. Sri. Anup Kumar Paul (Sonu), and 4. Sri. Santu Biswas (Bittu) are still threatening me. Sir they are trying to destroy me life fully.

Due to social prestige, I have tried to solve the matter with homely discussion and had not taken the help of legal proceeding, but now I need the help of Legal Proceedings.

In this circumstances I request you to save my life and take necessary action with a proper enquiry. And I also request you to recover my belongings.
