I, Krishna Saha, S/o. Sri Ishwar Chandra Saha, resident of Devidanga Bazar, P.O.- Champasari, Dist.- Darjeeling- 734003, would like to inform do hereby lodging this complain to you and narrating the facts and circumstances with a request to take appropriate legal steps against the below mentioned culprits and saved my life as well as for the safety and securities of my entire families. On dated 30/03/2022 i.e. yesterday in between 9 to 9:30 PM, one Mithu Mahanta, S/o. not known and Biraj Pal, both residing at Sukanta Nagar, Dist.- Jalpaiguri, along with his 5/6 unknown anti-social friends came to my Shop at Devidanga Bazar and wanted to meet with my Wife Smt. Then they(culprits) started blowing and kicked me continuously by showing sharp weapon, with an intention to kill me, when my wife tried to protect me, the below mention culprits pulls, grabbed and tiers the saree and blouse off of my wife and dishonour, outrage her modesty. Finding no other alternative I and my wife shouted for taking help from the neighbours but no one came to the spot for helping us due to their dangerous weapons in hand. After that they flew away. Again threatening and throwing filthy languages over my mobile no.7001650964 around 9.50 pm.
