Respected Sir,

I, Shri Indranil Datta, S/O. Dr Pradip Kumar Datta, aged 32 years, B.E. Engineer by profession, an inhabitant of Himanchal Vihar Phase I, P.O. & P.S. Matigara, Dist. Darjeeling, in the state of West Bengal have the honour to draw your kind attention to the following facts that:

- i) I am the Proprietor of "Ushasee Homestay", a West Bengal approved Gold Standard Home Stay located at Himanchal Vihar Phase I, Matigara, Darjeeling, W.B..
- There is an unregistered Club called Himanchal Vihar Sporting Club illegally constructed encroaching the land of Siliguri Jalpaiguri Development Authority at Himanchal Vihar Residential Complex. The usual activities of the club members are to extort money from the dwellers, Proprietor as well as business owners of Himanchal Vihar Residential Complex and, accordingly, as a part of their usual practice, they claimed a huge amount of money from me also as the Proprietor of the said Ushasee Homestay, but I refused to comply their demand for huge amount of illegal money demanded. More often they tried to malign me and the reputation of my Govt. approved Gold Standard Homestay and they threatened me for facing dire consequences.
- On 31st March in the early morning and around 8 A.M, while I reached my Homestay as a part of my usual visit, I came across a few Club members with the Leadership of Sri Milan Bose, Sri Bibhuti Bushan Thakur, Arun Kumar and a few others not known by name assembled at my Homestay premises dismantled and destroyed my property (stated below) broke my cash box and looted approximately Rs. 27,000/(twenty seven thousand) cash from my cash box.
- iv) On my arrival they without sparing any time attacked me, physically assaulted me used abusing languages and threatened to kill me. They snatched my Gold Chain (weighing 20 gm approximately) and a valuable wrist watch.
- v) These people (Milan Bose, Bhibhuti Bhusan Thakur, Arun Kumar...) vandalised my Homestay Office, damaged 2(two) Office CCTV Cameras, CPU of Computer Desktop, Computer Monitor, T.V. Monitor, Table etc...
- vi) They stole my Computer Hard Disc and CCTV- D.V.R with inbuilt hard disc.

Finally, they physically assaulted me and attempted to murder me uttering "sala ke mere felo", I marginally escaped myself from their attempt for the instant arrival of your Police Van. Thanks to your Police Personnel, they save my life. Contd page 2

I was arrested on 31st March 22 and released on Bail on the 3rd April 22. Being left alone at home as my parents were out for routine check up in Bangalore, (My father is a cardiac patient underwent By-pass surgery having High Blood pressure and Diabetic). On release, I took care of my father ill father first and, consequently failed to lodge written complain before your goodself.

I, therefore, request your kind intervention for the protection my old parents as well as for me.
