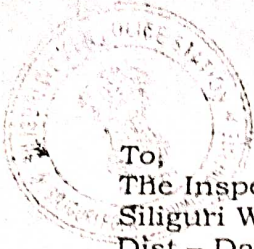

With due respect, I, Smt. Payel Saha Sarkar, wife of Biswajit Sarkar, D/o - Ganesh Saha, presently resided at Bhutia Market of Rental house, Permanent resident of (Parental Adress) Dinhata - I, Post and P.S. - Dinhata, Ward no - 13, of DMC Dist. - Cooch Bihar, ~~P.O. - Kadamtala, P.S. - Matigara, District - Darjeeling,~~ beg to inform you that I got married with one Biswajit Sarkar, S/O - Gopal Sarkar of Rabindra Nagar, in the year 2020-24 May.

It is pertinent to mention here that it was our love marriage and it was held at my in-laws house and after our marriage everything was alright but few months later I noticed that my husband is a habitual offender of keeping illicit relationship with several female persons and after knowing such type of activities of my husband whenever I tried to protest then he brutally assaulted me on several occasions.

It is very unfortunate that in between the time I become pregnant in the year 2022 and after knowing the news of my pregnancy he by any means tried to convince me for abortion and as I did not agree at last said Biswajit Sarkar along with all family persons assaulted me and compelled me for abortion against my will by their illegal acts.

It is to be noted here that since One year we are staying in a rented house, Care of Anirudhya Sengupta at 169/11, Kavi Guru Sarani, of Ghugumali Main Road, Rabindra Nagar, Siliguri - 734006, and my husband does not change his character rather he mostly have addicted towards the several ladies as there is none to ask any question and on protest he use to assault me once in a week at a regular course and does not care about me even does not receive my calls and if I asked anything then he did not reply me and lastly on 04-04-2022 He returned in the rented house at late night and at that time he unnecessarily started to urgue with me and giving pressure upon me to give mutual divorce and when I protested then he brutally assaulted me and confined me in a room and locked me from outside and at a deep night my husband tried to kill me by pressing the pillow on my face and for that reason I was treated in Hospitals.

It is very unfortunate to mention here that my husband wants to marry another lady and as because he along with his family members are somehow trying to driven out me from his house as well as from his life and only for this reason, I conceive baby thrice time, but on every occasion my husband along with the direct conspiracy of his family members namely 1. Ajanta Sarkar (mother), 2. Gopal Sarkar (father), 3. Ananta Sarkar (maternal uncle), 4. Tumpa Sarkar (sister) 5. Sandip Sarkar (husband of his sister), all are resident of Paschim Rampur, Jorai, Rampur, Coochbehar, 736207 (W.B.) forcefully fed me the abortion pill twice and once they make abortion and even before one week I was admitted in hospital for Hospital and at that time also my husband brutally assaulted me.

It is a planned conspiracy of my in-laws family members to oust me from the life of my husband and as such I am victimized day to day life and they are son dangerous and they can do everything to ruin my life as I am alone here and none to look after me and my widow mother is staying at Dinahata.

It is therefore prayed that I am passing my every moment with great fear and anxiety and you will be kind enough to enquire into the matter immediately and further be pleased to take appropriate legal action against above named culprits who wants to ruin my life by their illegal activities and illegally try to deprive me from my matrimonial life.
