I SI Avishek Lama of STF WB, HQ at Siliguri do here by lodge this complaint as suo-moto to the effect that today (09.04.22) at about 18.00hrs I have received a specific information provided by casual informer that 03 (Three) persons namely NurSalam of Lalgola, Md. Abdul and Md. Zalluddin of Manipur will carry huge quantity of Brown Sugar and they will reach near Central Plaza Hotel at about 19.00hrs to deliver the same to their associates.

The same was duly reduced in writing and intimating to Insp. BiswasroySarkar of STF WB, HQ at Siliguri who brought the information to the superior authority of STF headquarter and after obtaining necessary order a team of Special Task Force, West Bengal namely SIAVlshek Lamm, SI Norbu W. Dukpa, ASI SkavokurKundu, C/60 Pradip Ray and C/118 JayantaSarkar all of STF WB, HQ at Siliguri, moved out from STF office, HQ at Siliguri at about 18.05hrs along with laptop, printer, weighing machine and other necessary documents availing Govt. vehicle of STF WB. This refers to STF WB, HQ at Siliguri GDE No. 33 dated 09.04.22. At about 18.45hrs we reached near Central Plaza Hotel where I met with my informer. I could not find any willing public persons to accompany with us as witnesses during search and seizure.

At about 19.15 hrs our team noticed that 03 (three) persons coming in a white vehicle towards the Hotel. Our team with the help of informer identified those three persons as our target. Then the team mount the surveillance upon the suspected persons, our team then intercepted those three persons in the vehicle bearing Regd. No. NL 07 CA 3303 on the street in front of Central Plaza Hotel. I brought this development to the notice of Insp. BiswasroySarkar, of STF WB, HQ at Siliguri, who instructed me to detain those persons on the spot and he will arrive soon.

After that our team disclosed our identity to the intercepted persons showing our identity card. On being asked all the three persons disclosed their identity as 1. Noor Salam (31) S/O MofijulHoque of Lalgola, DakshinNatiberpara, PSLalgola, DistMurshidabad 2.Md. Abdul Guffar Khan (44) S/O Abdul Matalib of Lilong, Turel, Ahanbi PS Lilong, District Thoubal, Manipur 3. Md. Zalaluddin (46) S/O Lt. Md. Sanaton of Lilong, ChingkhamaMakha PS Lilong, Dist. Thoubal, Manipur.

Subsequently we informed them regarding the input available with us and requested them to co-operate. On being asked they also stated that they are carrying and possessing some Brown Sugar without having any legal papers.

After that the provisions of section 50 of the NDPS Act, 1985 ( as amended) was explained by me to all the three above noted detained persons and the same was given to them in writing stating that they have legal right to tender their personal search in front of a magistrate or a gazetted officer duly empowered under section 42 of the NDPS Act, 1985 (as amended) and further intimated them that if

they wish they may search every member of the searching team and the two witnesses before their personal search could be commenced. In writing they declined to search the team as well as they informed that there was no requirement for the presence of any magistrate or gazetted officer. Meanwhile at about 20.05hrs., Insp. BiswasroySarkar of STF WB, HQ at Siliguri arrived on the spot. I introduced Insp. BiswasroySarkar as gazetted officer to all the four detained persons. I then narrated the development to Insp. BiswasroySarkar in a nutshell.

After that search cum seizure was started at about 20.25hrs on 09.04.21 under direct supervision of Insp. BiswasroySarkar. At first I have searched Noor Salam (31) S/O MofijullHoque of Lalgola, DakshinNatiberpara, PSLalgola, DistMurshidabad, and recovered one dark blue colored mobile phone branded as Vivo bearing IMEI No. 869408040819810 & 869408040819802 and one white colored mobile phone (Keypad) branded as Samsung bearing IMEI No. 358971100389949.

Thereafter I searched Md. Abdul Guffar Khan (44) S/O Abdul Matalib of Lilong, Turel, Ahanbi PS Lilong, District Thoubal, Manipur, and recovered (i) one Voting Card in the name of Md. Abdul Guffar Khan s/o Lt. Md. Abdul Matalib of Lilong, Haoreibi, TurelAhandi, Lilong, DistThoubal, Manipur bearing No. DNS0068312, (ii) one PAN Card in the name of Md. Abdul Guffar s/o Mohammad Abdul Matalib bearing No. AWMPG85068, (iii) One driving license in the name of Md. Abdul Guffar Khan s/o Lt. Md. Abdul Matalib of LilongHaoreibi, TurelAhandi, DistThoubal, Manipur bearing No. MN0420200000979, Date of issue: 04.02.2020 and valid upto 03.02.2030 and (iv) One Aadhar Card in the name of Md. Abdul Guffar Khan s/o Lt. Md. Abdul Matalib of LilongHaoreibi, TurelAhandi, DistThoubal, Manipur bearing No. 812466676611.

I then searched Md. Zalaluddin (46) S/O Lt. MD. Sanaton of Lilong, Chingkhambakha PS Lilong, Dist. Thoubal, Manipur, and recovered i) One Registration Certificate bearing Vehicle No. NL07CA/3303 registered in the name of Md. Zalaluddin s/o Md. Sanatan of H No. 263, Tenyithe, Village Dimapur, Nagaland, (ii) One white colored Hyundai Creta Car (4 wheeler) SX bearing Reg. No. NL07CA/3303 with key, (iii) One Driving License in the name of Md. Zalaluddin s/o Md. Sanatan of Lilong, Chingkhambakha, PO & Lilong, Dist. Thoubal, Manipur bearing No. MN0420090003352, Date of issue: 30.04.2009, Valid Till 28.02.2025, (iv) One Voting Card in the name of Md. Zalaluddin s/o

I then searched the vehicle bearing Regd. No.NI. 07 CA 3303, in which they were in. I then asked them to produce the said contraband. Then they opened the bonnet of the vehicle and produced two brown coloured packets containing brownish powder which was tucked inside the front bonnet of the vehicle below the wipers. I then weighed the packets which weighed 1000 grams in total and tested a small quantity in the portable Drug Test Kit from each. The result showed positive result for Brown Sugar.

Thus, a reasonable belief having been formed that an offence has been committed in contravention of the section 18/21(c)/22(c)/25/27A/28/29 of the NDPS Act, 1985 (as amended) and that recovered Brown Sugar like substance were liable to be confiscated U/S-60 & 61 of the NDPS Act, 1985, the entire contraband of brown coloured dust believed to be Brown Sugar were seized U/S-43 of the NDPS Act, 1985 (as amended) under proper seizure list duly prepared by me. Took dated signature of the two Police witnesses, all the three owners of the goods, signature of Insp. BiswasroySarkaras gazetted officer and put my signature as seizing officer. Copy of seizure list was given to the detained persons.

The first packet containing 365 grams of brown coloured powder was marked as Exhibit A. I then took 5 grams each in two zip lock pouches from it as sample and security sample and marked them as Exhibit A1 and A2.

The second packet containing 635 grams of brown coloured powder was marked as Exhibit B. I then took 5 grams each in two zip lock pouches from it as sample and security sample and marked them as Exhibit B1 and B2.

Thereafter all the seized articles was been properly labelled, sealed with brass seal (STF WB SILIGURI). Took signature of the police personnel and all three owners of contraband goods in the labels and marked accordingly. Thereafter I have arrested above noted three persons after communicating their ground of

arrest and issued arrest memo accordingly. Prepared Inventory list, took specimen seal impression of brass seal (STF WB SILIGURI).

On being asked they have stated that since last two years they are dealing in this business in clandestine manner for wrongful gain. They bring brown sugar from Manipur.


Under the above circumstances a case under section 18/21(e)/22(e)/25/27A/28/29 of NDPS Act, 1985 may kindly be started against the three accused persons namely 1. Noor Salam (31) S/O Mofijul Hoque of Lalgola, Dakshin Natiberpara, PSLalgola, Dist Murshidabad 2. Md. Abdul Guffur Khan (44) S/O Abdul Matalib of Lilong, Turel, Ahanbi PS Lilong, District Thoubal, Manipur 3. Md. Zalaluddin (46) S/O Lt. MD. Samaton of Lilong, Chingkhambakha PS Lilong, Dist. Thoubal, Manipur and others involved in this racket.

Superiors of STF, WB have been apprised of the seizure, arrest and other proceedings made so far in this regard.
