Respectfully, I, Shri Parmeshwar Singh, resident 50 Bon Bihar, Bose Road, Howrah 1, beg to inform that there is a land in measuring 23.23 Acre situated at Mouza Panchkalguri, L.R. Plot nos. 336, 492, 493, 495, 715, 719, & 732 under Police station Matigara which belongs to my close relative Late. Thakur Gur Mukh singh and his sons and family. They reside in Lucknow Uttar Pradesh so they asked me to take care of their land and I Shri Parmeshwar Singh look after that land from some time.

Recently on 10-04-2022 around 12 PM some men named 1. Rahul Barman alias Shambhu S/o Parsu Ram Barman, 2. Rinku Singh S/o Dilip Singh Matigara Bazar and 2-4 other men started to dig on my relative's land with JCB no. WB 73 E 4212. I called police as soon I came to know and then Police took them in arrest. These men always create nuisance on this land. Earlier my relatives filed few complaints against them E.g. FIR 45/19 in Matigara Police station, and an FIR on Date 16-12-2021 for the same reason. And last in same reference on 17-02-2022 in Sadar Police station Darjeeling an FIR 19/22 has been filed by the office of SUB registrar Smt. Tshering Dolma Bhutia, Darjeeling.

Sir I came to know that they do the same thing with many innocent people. They make forge papers of the land and tell others that they or others are owner of the land and then sell or take advance against those lands. It's been coming in my notice that they are doing these things from a long time.

Please Sir I request you take a Strict action against these people.
