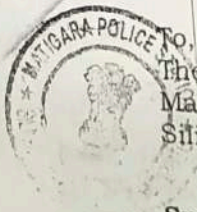

Sir,

In producing herewith one arrested accused named Krishna Pradhan (57), S/O- Lt. Ram Bahadur Pradhan of Patharghata Rajpori, PO- New Chamta, PS- Matigara, Dist- Darjeeling along with following articles under seizure from the possession of above noted Krishna Pradhan;

- (i) 04 (four) Blue coloured Plastic Jar each containing 50 liters of diesel and marked as Exhibit-A, Exhibit-B, Exhibit-C, Exhibit-D.
- (ii) One White coloured Plastic Jar containing 50 liters of diesel and marked as Exhibit-E.
- (iii) One Black coloured Plastic Jar containing 60 liters of diesel marked as Exhibit-F.
- (iv) One Black coloured Plastic Jar containing 30 liters of diesel marked as Exhibit-G.

I, SI Shekhar Adhikary of Matigara PS, SPC do hereby lodge this complaint to the effect that today on 11.04.2022 at 14.15 hrs I received specific source information that one person stored huge quantity of diesel in a room of Krishna Pradhan adjacent to his house at Patharghata Rajpori under PS- Matigara without any valid documents and taking any precautionary measures. The matter was diarized in Matigara PS GDE No. 512 Dt. 11.04.2022. After sharing the information with O/C Matigara PS, as per direction, I along with PSI Rantu Halder, PSI Newton Biswas, C/986 Rajib Sarkar and C/1008 Kanak Roy all of Matigara PS, SPC left Matigara PS for pursuing the information.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On the way I contacted two independent witnesses namely (1) Rajib Sha (28), S/O- Jailal Sha and (2) Swapan Chhetri (32), S/O- Hiralal Chhtri both Patharghata Rajpori, PO- New Chamta, PS- Matigara, Dist- Darjeeling and make them aware of the matter and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. At 14.55 hrs we reached at Patharghata Rajpori under PS- Matigara and being pointed by my source able to apprehended one person who on being asked, disclosed his identity as Krishna Pradhan (57), S/O- Lt. Ram Bahadur Pradhan of Patharghata Rajpori, PO- New Chamta, PS- Matigara, Dist- Darjeeling. On being interrogated, the apprehended person named Krishna Pradhan stated that he has stored diesel by illegal means for his wrongful gain.

Subsequently, in presence of the independent witnesses, searched has been made and found total 340 Liters (approx) of diesel which was stored in a room of Krishna Pradhan adjacent to the house at Patharghata Rajpori under Matigara PS.

On demand the detained person named Krishna Pradhan failed to produce any valid documents in support of storing fuel and on further interrogation, he admitted that he along with his other associates procured the said diesel, an essential commodity and combustible in nature, clandestinely and stored the same, without taking any precautionary and safety measures, for selling with increasing rate.

From the above facts, it is evident that the above noted person in connivance with others are involved in procuring of diesel in fraudulent means and stored the same which is combustible in nature and endanger to human life and property without taking any precautionary and safety measures. Subsequently, they sell the same in increased rate after breaching its equitable distribution, to their designed customers for their wrongful gain, contravening the norms of Essential Commodity Act, 1955.

Accordingly, I seized the above noted articles from the conscious possession of the above noted detained person named Krishna Pradhan in presence of independent witnesses and also arrested above noted Krishna Pradhan (57), S/O- Lt. Ram Bahadur Pradhan of Patharghata Rajpuri, PO- New Chamta, PS- Matigara, Dist- Darjeeling observing all formalities and informing the ground of his arrest. The whole process of seizure was made in between 15.55 hrs to 16.35 hrs.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person named Krishna Pradhan (57), S/O- Lt. Ram Bahadur Pradhan of Patharghata Rajpuri, PO- New Chamta, PS- Matigara, Dist- Darjeeling and others and arrange for its investigation.


