Sub: FIR Re: Domestic abuse and assault

Respected Sir,

I, Mrs. Mousumi Ghosh, w/o. Uttam Ghosh (Lattu),
Dastarath Pally, Behind Kali Madir, Siliguri-734001,
hereby want to inform you that my husband
Uttam Ghosh, has been continuously physically
assaulting me and torturing me mentally
for the last few years. I was silent so
far looking at my sons'. Now the level
of torture and assault has gone beyond
my tolerance. In the recent time, four
months ago, one tenant (husband Gopal
and his wife Riya Mondal) and my husband
have made my life into a living hell. My
husband is having physical relation with
Riya Mondal and I have found it out and
confronted my husband with proof that I
have. I could see my husband's phone records
and Riya Mondal and my husband's relation
is very clear. After asking my husband

about this relation, he beat me further and instead of asking that tenant to vacate the house, he asked me to leave my house. To save my life, because otherwise my husband could have killed me, I was forced to leave my house ^{on April 5, 2022 at 11:30 pm} and had to spend my night at the general waiting section of Siliguri Hospital. Thoughts of ending my life popped up multiple times in my head but thinking about my two sons (one 9 yrs. and the other 6 months) I could contain myself. I then took shelter at one of my friend's house. I could have taken shelter at my parents' house who stay in Paresnagar, Siliguri (very close to my house), but I could not fear that my husband would come and torture my parents too, because in the past too he tortured my parents verbally and assaulted me in front of them.

Some of the recent assaults are -

01/Mar/2022 my husband Uttam Ghosh beat me so hard that I had to be admitted to the Nursing home.

25/Mar/2022 on the day of Holi he beat me again and there after next few days in front of my elder son and neighbours.

Around the same time he unplugged the cylinder pipe and threatened to set the house, me and my sons on fire.

I am in constant fear of my life and my sons.

I sincerely look forward to your review of the situation and help me so I can ~~leave~~ live a life of dignity and ensure safety of my sons.
