In producing herewith 05 (Five) arrested accused persons named (1) Md Mustak (31) S/O Md Monsur of Adarsha Nagar Colony, Ward No-4, PS Siliguri, Darjeeling (2) Abhinash Roy (19) S/O Benu Roy of Mahanandapara, Adarsha Nagar Colony, Ward No-4, PS Siliguri, Darjeeling (3) Mithun Biswas (19) S/O Lt Prafullya Biswas of Dost Bandhu Lelin Sarani, Ward No-29, PS Siliguri, Darjeeling (4) Babu Sona Sarkar (19) S/O Lt Tulu Sarkar of Tikiapara, Matangini-2, Ward No-28, PS Siliguri, Darjeeling (5) Raju Paswan (24) S/O Sri Salit Paswan of Tikiapara, Matangini-1, Ward No-28, PS Siliguri, Darjeeling along with seized articles (i) one knife measuring 12" including wooden handle wrapped from the possession of Md Mustak S/O Md Monsur which was kept concealed on the back side waist (ii) one Hasua (sharp cutting weapon) measuring approx 14" including its wooden handle recovered from the possession of Abhinash Roy S/O Benu Roy which he was holding on his hand (iii) One iron rod measuring approx 25" pointed one end recovered from the possession of Mithun Biswas S/O Lt Prafullya Biswas which was holding on his hand (iv) One iron rod measuring approx 36" recovered from the possession of Babu Sona Sarkar (19) S/O Lt Tulu Sarkar (v) One torch light recovered from the possession of Raju Paswan S/O Sri Salit Paswan under proper seizure list.

I, SI Ashim Das of Panitanki TOP under Siliguri PS/ SPC do hereby lodge this written complaint against the above noted arrested persons to the effect that today on 10/04/22 at 00:15 hrs I received secret source information that 12-13 persons have been assembled beside Mahananda River Bank behind Surya Sen Park to commit dacoity in the locality. Immediately I intimated the tip of information to O/C Panitanki TOP and as per his kind direction I dialed the landline of GD Bank side Panitanki TOP GDE No-182 dated 10/04/22 and myself along with SI Uday Shankar Mandal, ASI Biswaji Ghosh, ASI Gazi Rahaman, ASI Biswaji Saha C/2084 Subhasish Das, C/233 Nagen Ch Barman, left for Mahananda River bank behind Surya Sen Park to verify the veracity of the information. This refers Panitanki TOP GDE No-183 dated 10/04/22 and MEC No-455/22 dated 10/04/22. At about 00:45 hrs I along with Police party arrived at the spot to beside Mahananda River Bank behind Surya Sen Park and after keeping our vehicle at a distant place we proceeded towards Mahananda River Bank behind Surya Sen Park on foot and being indicated by the source found from the considerable distance that a gang of 12/13 persons were assembled beside Mahananda River Bank behind Surya Sen Park and they were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of police party, they scattered in multi direction and started fleeing away but after a hot chase we manage to apprehended 05 (Five) persons and others were fled away from the spot. On interrogation, the apprehended persons disclosed their name & address as noted above, and started giving incoherent statement regarding their presence/gathering in the same place also. On further grilling they stated that, they along with 7/8 persons were assembled there in preparation to commit dacoity. Accordingly, I managed to call two independent witnesses on the spot and on being search in presence of the independent witnesses from the apprehended persons recovered (i) one knife measuring 12" including wooden handle wrapped from the possession of Md Mustak S/O Md Monsur (ii) one Hasua (sharp cutting weapon) measuring approx 14" including its wooden handle recovered from the possession of Abhinash Roy S/O Benu Roy (iii) One iron rod measuring approx 25" pointed one end recovered from the possession of Mithun Biswas S/O Lt Prafullya Biswas (iv) One iron rod measuring approx 36" recovered from the possession of Babu Sona Sarkar S/O Lt Tulu Sarkar (v) One torch light recovered from the possession of Raju Paswan S/O Sri Salit Paswan.

Accordingly, I seized the above noted recovered articles as per seizure list in presence of witnesses and conveyed the same in between 01:25 hrs to 01:50 hrs and I arrested them U/S 41 Cr.P.C. after explaining the charges against them.

In view of the above facts and circumstances I pray that a specific case may kindly be started against (1) Md Mustak S/O Md Monsur (2) Abhinash Roy S/O Benu Roy (3) Mithun Biswas S/O Lt Prafullya Biswas (4) Babu Sona Sarkar S/O Lt Tulu Sarkar of Tikiapara, (5) Raju Paswan S/O Sri Salit Paswan and others under proper Section of law.
