Sir , we are doing a business of catering in Siliguri. So In this purpose he asked me to send menu rate. After 1.30 hrs he send me a dinner menu at about 14.56 hrs in whatsapp number 8677845447. We send the rate of Rs. 91000 for the dinner party for 100 invities at about 6.00 pm. After agree we demand advance of 50% to do the same. Then he told that my cashier will be transfer of Rs. 40,000 to your account. After that I have received a phone call from m no 86096011398 and told me that his name is Vikash patel . he want to send the advance of Rs. 40,000 through google pay or phone pay . So he send a linked of rs. 20,000 to pay in this way he deducted 3 times of Rs. 20000 \*3 = 60,000 from my account number 20308492755 (SBI) through my phone pay number 9832049402 . Further he deducted from my another account number 31565016643(SBI) and credited to his credit card number 4341xxxxxxxx5449 of Rs. 40,000 and then two times Rs. 5000 ( 10,000) . Again deducted Rs 10,000 to another phone pay number 9832059005 from account number 17060110017807(uco bank) . At that time I was not able to check my balance in my account number. In this way Rs. 1,20,000 ( Rupees One lakh Twenty Thousand ) had been deduct from my account number.

So please help me to find the culprit and lodge a diary against them.
