Sir,

In producing herewith one arrested accused person namely Rehan Alam (20) s/O Fazlu Rahaman of Gunjaria bazaar ,P.S-Islampur ,Dist.Uttar Dinajpur under arrest along with the following seized articles:-

- i) 1(One) Iron made(Wooden butt) Improvised fire arms (Single Shooter) measuring about 9.4" (approx) inches in length including its butt, body and barrel in normal position with trigger and firing pin in working condition marked as Exhibit "A"
- ii) 01(One) round live ammunition which was loaded in the improvised fire arms (marked as Ex-A) marked as "A-1".

I PSI Sumit sarkar of Pradhannagar PS under Siliguri Police Commissionerate would like to lodge this written complaint against Rehan Alam (20) s/O Fazlu Rahaman of Gunjaria bazaar ,P.S-Islampur,Dist.Uttar Dinajpur to the effect that today i.e. on 11.04.2022 at 14.25 hrs. I received a source information that, one person is roaming at Siliguri Junction area , Pradhan Nagar, Siliguri possessing illegal firearms with a view to commit heinous crime a in Siliguri area. Accordingly, the fact was diazied vide Pradhannagar PS GD Entry No. 846 date 11.04.2022 and I informed the fact to you. As per your direction myself along with ASI Debaslah Das, ASI Ashit Singha , CV-992 Jagadish Biswas, CV 645 Pankaj Gupta all of Pradhannagar PS immediately rushed to the spot to verify the veracity of the information vide Pradhannagar PS GDE No. 847 dtd.11.04.2022 at 14.30hrs.

On way, I called two witnesses namely (1) Ajay Barma s/O Lt Harak Chand barma of Gurung Basti ward no-03, PS - Pradhannagar Dist -Darjeeling and (2) Rameswar Prasad barma s/O Lt. Ram Suresh barma of do, and narrated them the information in hand after disclosing our identity and requested them to accompany with us as witnesses. Accordingly, he had given his consent and become willing to accompany with us. We reached near the spot as identified by the source at about 14.45 hrs. and managed to apprehended the above noted person. Then I searched his person as per provision of law and on search I could recovered above noted improvised firearms loaded with one round ammunition from the exclusive possession of arrested person as mentioned above which he kept conceal position in the back side of his waist.

On interrogation he disclosed his name and identity as noted above. On demand he failed to produce any valid documents or license in support of possessing Fire Arms and ammunition. He also admitted that he has procured the fire arms and ammunition illegally from Islampur to commit crime against property. Accordingly, the above noted firearms and ammunitions has been seized in between 14.55 Hrs to 15.45 hrs under proper seizer list in presence of the witnesses duly signed by him and acknowledge by the apprehended person. There after sealed and labeled the seized the articles. Then I arrested the above noted accused person after communicating the ground of arrest and issued memo of arrest for violation of provisions of Arms Act.

Under the above circumstances, I pray before you that a specific case may kindly be started against the arrested accused person namely Rehan Alam (20) s/O Fazlu Rahaman of Gunjaria bazaar ,P.S-Islampur,Dist.Uttar Dinajpur under proper section of law and arrange for its investigation.
