Respectfully I beg to inform you that being a Police officer when I attend to our ACP Investigation Office, Pradhannagar (situated at old Pradhannagar P.S) today on 11/04/2022 at near about 3.45 pm by my Motor vehicle on the road in front of Malhotra Tower then one vehicle No. WB-73 D 0682 was standing on the road for unloading some goods of there shop. Due to wrongful standing of the vehicle No. WB-73 D 0682 both side so many cars and vehicle had stood and not to move on their destination. My vehicle was felt there traffic jam.

Then I Shaw that situation and understood that wrongful standing of the vehicle No. WB-73 D 0682 traffic movement has been stopped. Being a police person to think about all others traffic movement I arrived in front of the driver of vehicle No. WB-73 D 0682 who was in the vehicle of his driver shit & I requested him to remove his vehicle from this place sometime because of that traffic has been stopped due to wrongful standing of your vehicle. Then he anxiously throwing his word "Hum Nehi Hatayenga, Kia Karoge ". Again I requested him politely and said I am a police officer, it is also our duty to public interest. He didn't care and jumped out of his seat and suddenly punched me before my chest when I felt down in the earth, he climbed on top of me and grabbed me by the throat & snatched one golden wring from my left hand. Some unknown passerby rescues me from his brutal hand and almost faint condition they shift me to Emergency ward of Siliguri District Hospital where I have took treatment and released from there with medicine. I still have a sore throat.

In this regard I have to request you, kindly investigate this matter and took necessary action from your end.
