With due respect, I, beg to state as follows:-

- 1) That I have a travelling business namely "Sima Five Star Travels", situated at Hill Cart Road, Opp. Hotel Court Yard, Mallaguri, P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling.
- 2) That one Roshan Chhetri of Vill. - Simaltapu, P.O. Simaltapu, P.S. Srirampur, Dist. Kokrajhar, Assam who is a driver of a bus namely "Joy Ramkrishna".

That today at about 6:50 p.m., said Roshan Chhetri along with 5-6 persons came to my said office with drunken condition and started to abuse me with filthy languages and told that they will see my said company and stop my buses in its routes and my buses shall not be able to run from Siliguri to Shilong, Meghalaya.

That when I raised protest and tried to convince them not to create any nuisance in my office and go outside, they became furious and assaulted me by fists and blows and for which I fell down on the ground and they also kicked me mercilessly.

That when I fell down on the ground, the said Roshan Chhetri snatched a gold chain with gold locket weighing about 40 grams from my neck.

So, I therefore, request you to investigate the matter and to take necessary legal action against said Roshan Chhetri and also against his associates and to take necessary measures for my safety and security. And for this kindness, I shall much oblige to you.
