I Smt. Pooja Devi, wife of Amit Gupta, resident of Champasari Main Road, Near Suji Mill, P.O. Champasari, P.S. Pradhan Nagar, Siliguri, Dist: Darjeeling.

I beg to inform you that on 09/04/2022 at about 08.45 PM one of our tenant namely Rohit Gupta son of Ram Parikshan Gupta who runs his shop of garments and also repairs mobile phones in the name and style of Maa Santoshi Textiles. It would not be out of place to mentioned here that I had given my mobile phone to format and he repaired my mobile phone and came to my house at above mentioned time in absence of my husband to return my mobile phone as he was aware that my husband has gone out for duty as he works as a security guard (Night Shift). Then the said person Rohit Sharma suddenly hold my hand and grabbed me tightly in his arms and started touching my private parts and when I tried to rescue myself he also kissed me and stated that I would not tell this to anyone and asked to co-operate with him.


Then I started to shout and somehow I rescued myself by pushing him and the said person started to negotiate with me stating not to tell about this incident to anyone, then I told him to go out from my house or else I shall shout and scream for help then the said person went out of my house, after this incident I was very much scared and nervous and had not even told my husband about the said incident but seeing me nervous and scared my husband asked me about what has happened to me, then finding no other option I narrated the entire incident to my husband then my husband suggested me to file a complaint before your good office as the above noted person may do such act in future.

Therefore I have come before your good office and request you to kindly look into the matter and help me with Justice as I stay alone with my younger daughter as my husband works as security guard (night shift) and take serious action against the above noted person and help me and my family.
