Sir,

I, Sri Arindam Roy Chowdhury, Son of Sri Anjay Roy Chowdhury, resident of Vivekanda Pally, Post Office Kadamtala, Police Station Matigara, District Darjeeling, PIN Code- 734011, do hereby lodging a written complain against Sri Sukanta Paul and others for the following:

That I had purchased a piece of land measuring 73 decimals situated within Mouza - Ambari Falakata, R.S. Sheet No.1, L.R. Plot No.838, L.R. Khatian No. 960, J.L. No.22, under Ambari Falakata Gram Panchyat area, Police Station - NJP, Dist. Jalpaiguri by virtue of a registered Sale Deed being No. 9389/2021, registered at the office of the A.D.S.R. Bhaktinagar, registered in Book No.I, Volume No.0711-2021, Pages from 260498 to 260524 on 17-11-2021 from Alauddin Md. & Phajiraddin Md, both are sons of Late Majid Mohammad.

That after purchasing the said land I demarketed the land with pucca boundary wall. But, since 8th march 2022 few persons (Sukanta Paul, Manish Agarwal, Vikash Agarwal, Ankit Kr. Singhal and their agents) started disturbing my peaceful possession over the land.

That after the disturbance by the above named persons, I approached to the Ld. Civil Judge, Junior Division, 1st court at Jalpaiguri and the Ld. Court was pleased to pass an order in Title Suit No. 131/2022 on 22.03.2022, restrained the above named persons along with their men and agents to entering into the suit land.

But, on yesterday (i.e. 28.03.2022), the Defendant No.1, Sri Sukanta Paul, Son of Sri Subodh Paul, resident of S.P. Mukherjee Road, Khalpara, P.O. Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling, PIN - 734005 and few other persons forcibly tried to entered into the suit land violating the court order passed by the Ld. Civil Judge, Junior Division, 1st court at Jalpaiguri.

I, therefore, request you please take immediate suitable legal action against the aforesaid culprits and others and thus oblige thereby.
