Respected Sir,

With due respect and humble submission that I, SI (UB) Dawa Tshering Sherpa S/o Sri Mingma Sherpa of Bhaktinagar PS, SPC would like to lodge a written complaint against the owner and manager of "THE BARCODE" situated at Vega Circle Mall, under Bhaktinagar PS, Dist: Jalpaiguri to the effect that on 12.04.2022 at 17.50 hrs received a written information from LSI Sunanda Sonar of Pradhan Nagar PS, Siliguri PS vide Pradhan Nagar PS DR No 1972/22 dated 12.04.2022 and intimate at Bhaktinagar PS, SPC that on 20.03.2022 at about 14.30 hrs one minor girl namely Nandini Kanoria (17) left her home for a well known restaurant-cum-pub styled as 'THE BARCODE' situated at Vega Circle Mall, under Bhaktinagar PS, Dist: Jalpaiguri with her friend namely Vedika Pradhan and there they met with one Sagar Chettri friend of Vedika Pradhan who forced Nandini to drink alcohol at "Bar Code". Nandini got intoxicated and approached for help to one of her friend Pratham Mitra who was present there. But her friend Vedika and Sagar Chettri took her to JW Mariott, Court Yard hotel under Pradhananagar P.S in intoxicated condition and later on Pratham came there at Hotel Courtyard, Mariott and Vedika left for home with Pratham. Then alleged person Sagar Chettri finding Nandini alone in the hotel room then he forcefully established sexual intercourse with the minor girl Nandini Kanoria(17) years. Over this matter a specific case has been started at Pradhan Nagar PS vide Pradhanagar P.S Case No: 214/22 Dt: 22.03.2022 U/S 6 of POCSO Act. Accordingly the matter was diarized in GDE vide Bhaktinagar PS GDE No 1972 dated 12.04.2022 and I/C Bhaktinagar PS endorsed to me for its enquiry, being endorsed by I/C, I had been to 'THE BARCODE' at Vega Circle Mall, under Bhaktinagar PS, Dist: Jalpaiguri and conducted local enquiry both open and secret and during enquiry it could be learnt from CCTV footages of "BAR CODE" that on 20.03.2022, the staffs of 'THE BARCODE' of Vega Circle Mall, under Bhaktinagar PS, Dist: Jalpaiguri were sell or delivers the intoxicating drink to the minor below eighteen(18) years girls without obeying the rule and regulation of Bengal Excise Act . Hence the owner and manager of "THE BARCODE" of Vega Circle Mall, under Bhaktinagar PS, Dist: Jalpaiguri violated the guidelines of Bengal Excise Act.

Hence I pray before you that a specific case under proper section of law may kindly started against the owner and Manager of "BAR-CODE", Vega Circle, P.S: Bhaktinagar, Jalpaiguri for violation of laws of Bengal Excise Act and serving alcoholic beverages to minor girls.

Sir,

With due respect and humble submission I beg to state the fact of the case in brief is that on 22.03.2022 received one(01) written complaint from Sri Amit Kanoria s/o Lt. Gouri Shankar Kanoria of Jyoti Nagar, Shree Krishna Sargam Apartment, PS-Bhaktinagar Dist-Jalpaiguri to the effect that on 20.03.2022 at around 14:30 hrs his daughter namely Nandini Kanoria (17) left home for a well known restaurant-cum-pub styled as 'The Barcode' situated at Vega Circle Mall with her friend Vedika Pradhan. There they met with one Sagar Chettri friend of Vedika Pradhan who forced Nandini to drink alcohol at Bar Code. Nandini got intoxicated and approached for help to one of her friend Pratham Mitra who was present there. But her friend Vedika and Sagar Chettri took her to JW Mariott, Court Yard under Pradhananagar P.S in intoxicated condition and later on Pratham came there at Hotel Courtyard, Mariott and Vedika left for home with Pratham. Then alleged Sagar Chettri finding Nandini alone in the hotel room established sexual intercourse forcefully with Nandini. Over this written complaint the above mentioned case has been started by I/C Pradhanagar P.S and endorsed me for its investigation.

During the course of investigation as per the leading statement of the V.G, other available witnesses and CCTV Footages of " Bar-Code" reveals the fact that the minors, aged below eighteen(18yrs) were served alcohol violating the guidelines of Bengal Excise Act. Hence I pray before you to kindly taking necessary steps against the owner and Manager of " Bar-Code", Vega Circle, P.S: Bhaktinagar, Jalpaiguri for violation of laws and serving alcoholic beverages to minors.
