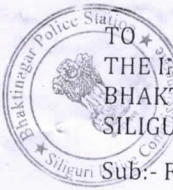

Sir,

In producing here with the one arrested accused person namely (1) Pankaj Talukdar (25 yrs) S/o Pradip Talukdar of Dakhin Bhanga more, Near Kali Mandir, PS- Mathabhanga, Dist- Cooch Behar A/P Durga Nagar, Near Scon Vatika Apartment, PS- Bhakti Nagar, Dist- Jalpaiguri (2) Md. Intej (32 yrs) S/o Md. Azad of Ashraf Nagar, Near Masjid, PS- Bhakti Nagar, Dist- Jalpaiguri alongwith the following seized articles as per proper seizure list:

- 1] 02 Bottles of Royal Star Golden Brandy each Bottle containing 750 ml.
- 2] 05 Bottles of Royal Blue Premium Whisky each Bottle containing 750 ml.
- 3] 12 bottles of "Himalaya Gold" premium 60 UP country spirit each bottle containing 600 ML
- 4] One Blue and Black coloured carrying bag .

I, ASI Dipak Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused persons to the effect that on 12.04.2022 while performing special raid duty under Bhaktinagar PS area vide BKN PS GDE No.519 Dated. 12.04.2022 at about 17.55 Hrs I, received a source information that the above noted accused persons have possessed huge amount of Liquor carrying in a carrying bag at Silisia Sporting Club, Near Surya Sikha Sarani under Bhakti Nagar PS for the purpose of selling the same to local customers. Accordingly the information shared before you and as per your kind direction I along with ASI Rabin Lama, Constable C/762 Debraj Biswas, CVF-014 Labanyamoy Barman headed towards Surya Sikha Sarani to verify the veracity of the information. At about 18.30 hrs we reached at Surya Sikha Sarani and as shown and being identified by the source held raid and apprehended two persons who disclosed their identity as noted above. Further maintaining their decency and observing all formalities searched them and recovered huge amount of above noted seized liquor with one carrying bag from their possession. On demand they could not produce any valid documents/licence in respect of the recovered liquor. On enquiry the apprehended persons admitted their guilt and confessed that they have possessed above noted liquor at their house for the purpose of selling to his designed customers. He also stated that they have been doing this illegally since long without any valid licence or Documents for their wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 20.10 Hrs to 20.40 Hrs. As they have violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused persons u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused persons namely (1) Pankaj Talukdar (25 yrs) S/o Pradip Talukdar of Dakhin Bhanga more, Near Kali Mandir, PS- Mathabhanga, Dist- Cooch Behar A/P Durga Nagar, Near Scon Vatika Apartment, PS- Bhakti Nagar, Dist- Jalpaiguri (2) Md. Intej (32 yrs) S/o Md. Azad of Ashraf Nagar, Near Masjid, PS- Bhakti Nagar, Dist- Jalpaiguri under proper section of law and arrange for its investigation.
