Sub: Encroachment and illegal possession of my tribal land by Land mafias

Most Respected Sir,

I beg to state the following few lines for your kind consideration. I belong to a Scheduled Tribe as per the notified list and I am residing in Kurseong and I have, along with my four siblings, inherited a plot of land measuring 42 Kathas as per schedule below, from my father, Late Atendup Sherpa.

Sometime in 2019, in our absence, some anti-social people and land mafias namely, (1) Saudagar Roy, son of Late Bansi Roy, (2) Neelam Anand, wife of Late Kiran Kumar Anand, and (3) Munna Gurung, daughter of Late Ram Bahadur Gurung all resident Shiv Mandir Road, Near Gokul Apartments, Punjabi Para, P.O. & P.S. Siliguri, Dist. Darjeeling, have encroached upon around 22 Kathas of our inherited land and have constructed kutcha structure upon the land and are dwelling there with their families, thereby dispossessing us.

I along with my brother and sisters have tried our best to evict these people time and again for the past couple of years, but without any result. Every time we go to our land to confront these people, they gang up on us and created a big fight during which they abuse us with filthy and coarse language and call us uncivilised mountain people. They also give us death threats and say that they have tons of money and are high caste and we are uneducated janglees from the mountains and that we cannot touch them and if they want they will dispossess us from our entire property.

We have been wrongfully dispossessed from our own land and finding no relief from any quarter, we have been forced to approach your Hon'ble self.

I am optimistic that your immediate attention and sympathetic action will result in restoration of possession of our land back to us and so justice shall prevail.
