The undersigned beg to state as follows:-

1. That I had purchased a plot of land from Anil Shah in the year 2018 and he had committed fraud with me by getting the other plot of land registered rather than the one which I had actually purchased.
2. On dated 21.03.2022 I went to visit my land situated at Vill: - Palash, PO. : - Champasari Mauza 34, P.S:- Pradhan Nagar, Block Matigara, Dist.:- Darjeeling Pin 734003, Siliguri. During my visit in the afternoon the accused no. 1 Anil Shah came to me and gave me death threats with dialogue like '6 inch chota kar dunga' Mr. Anil Shah further used lines like 'tumhara land boundary JCB se destroy kar ke river me phak denge or tumko bhi yaha se bhaga denge' and also pushed me out of the land boundary. Accused no. 1 repeatedly threatened me with dire consequences.

So, under the above fact and circumstances your honour would graciously be pleased admit this pition and start a specific case against accused person.
