Sub: FIR against Ram Niwas Agarwal , S/o. Jaylal Agarwal and his three sons, namely Rajesh Agarwal , Mukesh Agarwal, Deepak Agarwal together with their depute anti Socials.

Sir,

I Shri Mani Singh, S/o. Lt. Nageshwar Singh, resident of Pradhan Nagar, P.S. Pradhan Nagar, Dist. Darjeeling , do hereby lodge this FIR on the following effects with the request for taking immediate action.

1. That I am law - abiding citizen and I myself , my father Lt. Nageshwar Singh and Sumitra Devi (now deceased) , were holding the physical possession of the below scheduled since long 50 years and till today after their demise I alone is in physical possession of the below schedule land.

2. That Ram Niwas Agarwal, by way unlawful means and by preparing some fiction documents, in order to snatch the physical possession from my hand , had filed one OC Suit being no. 24/1987 before the Ld. Civil Judge (Jn. Div.) at Siliguri and after long battle of 34 years, I have won the case and the Ld. Court rejected the suit filed by Ram Niwas Agarwal vide judgment dt. 08/12/2021 and thus Ram Niwas Agarwal and his three sons are having no right in respect of my land mentioned in OC Suit No. 24/1987 and also having no right to disturb my physical possession.

3. That it is unfortunate to state that Ram Niwas Agarwal is having nexus with the land mafia and by influencing them, Ram Niwas Agarwal , his three sons together with their deputed anti-socials have started to disturb my physical possession and had taken venture to occupy land and against the said unlawful action I have already lodged one written complaint before your office and met personally on 24/12/2021 and after lodging the FIR the above noted persons did not take unlawful action to occupy my land forcefully for certain days but unfortunately again by deputed some land mafias & antisocial have taken venture today i.e. on 23.3.22 to occupy the front portion of my land and also to occupy my land forcefully and one getting the said information I rushed to the land and challenged their unlawful action but unfortunately the deputed anti socials with some

dagger have threatened me for dire consequences stating that they have been instructed by Ram Niawas Agarwal and by his three sons to occupy the same and they will murder me if I resist further against their venture and as such finding no option, I am lodging this FIR against Ram Niawas Agarwal and his three sons namely Rajesh Agarwal , Mukesh Agarwal , Deepak Agarwal of Udham Singh Sarani, Ashrampara, Siliguri , Rambalak Das and Raju Das S/o. Rambalak Das together with their deputed anti-social for committing the offence with the request to start specific criminal case against them and to arrest them immediately to ensure justice and I also request you to take appropriate action immediately against them so that they above noted culprits will not be able to occupy my land forcefully taking the law in their hand and for taking appropriate action against them to protect my life and life of my family members.
