With due respect I would like to inform you that myself & my elder son Krishna Malpaharia son of Late of is being tortured by my elder son's wife Smt. Bishakha Saha Malpaharia since after their marriage. My youngest son Sri Bishnu Malpaharia is living with his wife just after our house. I am working as a daily rated worker (Jogali).

Since after marriage of my elder son's wife Smt. Bishakha is torturing us in various ways and trying to grab my property with the nexus of one Tapash Kar ((M-9932290224) son of Late Nirmal Kanti Kar of Sitalkuchi, Mathabhanga, Coochbehar. They are having illicit & extramarital affairs.

My son's wife Bishakha is having an illicit & extramarital after with Tapas Kar (M-9932290224) when we objected for their illegal & illicit relations they become furious and started torturing us and uses filthy language even threatened us with dire consequences. Said Tapas Kar & in my son's wife Smt. Bishakha Saha Malpaharia beaten us & threatened for life and ultimately we were compelled to vacate our premises and also my worship room (Puja Ghar) for their inhuman torture. We have a shop in front of our house is being constructed by her forcefully and taking rent depriving us.

We are tribal people peace loving but due to constant threat for life we had to vacate our property & valuable articles due the torture of said Tapas Kar & my son's wife. I am a daily rated worker and at present I have no shelter because of my elder son's wife Smt. Bishakha Saha Malpaharia & illegal acts of her partner Tapas Kar (M-9932290224).

Tapas Kar & my son's wife Smt. Bishakha Saha Malpaharia sometimes beat me & threaten us constantly to transfer our property in their names. We are helpless and to save our life left the house.

Under the circumstances, you are requested to kindly intervene into the matter and protect us so that we may enter into my house.

Copies of some photographs of my son's wife Smt. Bishakha Saha Malpaharia are attached for her obscenity & extramarital affairs.
