In producing herewith two arrested accused persons namely Biswajit Das (48) s/o Lt. Bhupendra Nath Das of Pradhan Nagar, Ward No. 2, Bagha Jatin Colony, PS Pradhan Nagar, Dist Darjeeling and Raushan Kumar (25), S/O- Sanjeet Kumar Sah of Khanpur, PO -Khanpur, Dist-Samastipur, Bihar - 848117 along with following articles under seizure from the possession of above noted Biswajit Das and Raushan Kumar;

- (i) One White colored utility vehicle Bolero pick-up showing number plate vide WB 19 H 0507 and Engine No. GHH1B15045 and Chassis No. 'Erased'
- (ii) One White colored utility vehicle Bolero pick-up without Number Plate and without backside body and Engine No. GHE1B20399 and Chassis No. 'Erased'

I, SI Abhishek Theengh of Matigara PS, SPC do hereby lodge this complaint to the effect that today on 13.04.2022 at 15.45 hrs I received specific source information that some persons have clandestinely stolen two pick up utility vehicle mentioned above from somewhere and have been using the same with West Bengal registration number and presently both the vehicles are kept at 'Bishu Garage' at Paribhan Nagar under PS Matigara, Dist Darjeeling. The matter was diarized in Matigara PS GDE No. 615 Dt. 13.04.2022. After sharing the information with O/C Matigara PS, as per direction, I along with PSI Shekhar Adhikary, ASI Nitai Mandal, C/986 Rajib Sarkar and C/1008 Kanak Roy all of Matigara PS, SPC left Matigara PS for pursuing the information.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

At 16.10 hrs we reached at Paribhan Nagar under PS- Matigara and being pointed by my source apprehended above noted two accused persons namely Biswasjit Das and Raushan Kumar and also found above noted two vehicles One White colored utility vehicle Bolero having number plate vide WB 19 H 0507 and One White colored utility vehicle Bolero having no any Reg. No kept at 'Bishu Garage' at Paribhan Nagar.

Subsequently, being interrogated the apprehended two persons disclosed their identity as above but failed to produce any vehicular documents in respect of the above noted vehicles. Subsequently I checked the above noted number plate online and found vehicle having number plate WB 19 H 0507 has Engine no. TBF1K85975 and Chassis No. MA1ZN2TBKF1K74710 but the recovered vehicle having number plate WB 19 H 0507 has Engine No. GHH1B15045 and Chassis No. is found erased. On subsequent checking through Engine No. GHH1B15045, the vehicle is found having Reg. No. BR 09 GA 1899 and Chassis No. MA1Z2GHKH1B23189. The other recovered vehicle having Engine No. GHE1B20399 is found having Reg. No. BR 09 M 8900 and Chassis No. MA1ZN2GHKE1B25943.

Further being interrogated, apprehended person named Biswajit Das disclosed that he is the owner of the garage and further stated that Raushan Kumar and others provides him stolen vehicles for modifying/changing of chassis/Engine numbers. Accordingly, he does necessary changing/modification for selling the same to their designed customers.

The apprehended Roshan Kumar being interrogated, admitted his involvement with others in procuring of stolen vehicles from Bihar side and bringing in 'Bishu Garage' at Paribahan Nagar to Biswajit Das using different number plates for modifying/changing of chassis/Engine numbers of such procured vehicles. And, after necessary modification they sell the same to their designed customers for their wrongful gain.

Both the apprehended accused persons also revealed that they are involved in a racket of procuring vehicles by illegal means and using different registration numbers after erasing/tampering of existing Engine/Chassis Numbers of such vehicles and subsequently to sale such vehicles to their designed customers for their wrongful gain.

From the above facts, it is evident that the above noted recovered vehicles are stolen vehicles and the above noted persons in connivance with others are involved in procuring of vehicles by illegal means and using different registration numbers after erasing/tampering of existing Engine/Chassis Numbers of such vehicles and subsequently to sale such vehicles to their designed customers for their wrongful gain.


Accordingly, I seized the above noted vehicles from the conscious possession of the above noted detained persons namely Biswajit Das and Raushan and also arrested them observing all formalities and informing the ground of their arrest. The whole process of seizure was made in between 16.55 hrs to 18.15 hrs.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely Biswajit Das (48) s/o Lt. Bhupendra Nath Das of Pradhan Nagar, Ward No. 2, Bagha Jatin Colony, PS Pradhan Nagar, Dist Darjeeling and Raushan Kumar (25), S/O- Sanjeet Kumar Sah of Khanpur, ps Khanpur, Dist - Samastipur, Bihar - 848117 and others and arrange for its investigation.


