In producing herewith five (05) arrested accused persons namely (i) Raju Biswas(22), S/O- Ramanath Biswas of Parimolnagar, PO+PS- Matigara, Dist- Darjeeling, (ii) Suraj Sha(19), S/O- Somnath Sha of Khudirampally, PO+PS- Matigara, Dist- Darjeeling, (iii) Sanjoy Das(40), S/O- Kshitish Das of Ghughumali, Chyanpara, PO- Ghughumali, PS- Bhaktinagar, Dist- Jalpaiguri, (iv) Sudeb Das (28), S/O- Anil Das of Ghughumali, PO- Ghughumali, PS- Bhaktinagar, Dist- Jalpaiguri and (v) Sonatan Das (30), S/O Gopal Das of Ghughumali, PO- Ghughumali, PS- Bhaktinagar, Dist- Jalpaiguri ( not verified) arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made sword measuring 20 inch (approx) including wooden butt from the possession of Raju Biswas which was kept concealed on his back side.
- (2) One iron made 'Knife' measuring 13 inch (approx) from the possession of Suraj Sha which was kept on his right hand.
- (3) One iron made 'Kukri' measuring 14 inch (approx) from the possession of Sanjoy Das which was kept on his right hand.
- (4) One iron made Crowbars measuring 25 inch (approx) in length found from the possession of Sudeb Das which was kept on his right hand.
- (5) One iron Rod measuring 29 inch (approx) in length found from the possession of Sonatan Das which was kept on his right hand

I, PSI Shekhar Adhikary, S/O- Lt. Sonatan Adhikary of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Raju Biswas(22), (ii) Suraj Sha(19), (iii) Sanjoy Das(40), (iv) Sudeb Das (28) and (v) Sonatan Das (30) and others namely Niroj, Mona, Arjun Singh, and Robin Singh to the effect that today on 14.04.2022 at 01.15 hrs received a sources information that 14/15 youths have assembled at Phansidewa More, Railway Under-Pass under Matigara PS with a view to commit dacoity in a house at Sharada Pally, Shibmandir area. The fact was diarized in GD vide Matigara PS GDE No- 630 dated 14.04.2022. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Nitai Mandal, PSI Rantu Halder, PSI Abhishek Theengh, C/986 Rajib Sarkar, C/1008 Kanak Roy, CV/387 Sukumar Barman left for the place to work out the information. This refers Matigara PS GDE No. 631, Dt. 14.04.2022. At about 01.45 hrs. after reaching near Phansidewa More, Railway Under-Pass under PS- Matigara I met my source and being pointed by the source we started walking towards Phansidewa More, Railway Under-Pass. At 01.55 hrs. we reached at Phansidewa More, Railway Under-Pass and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted five (05) accused persons along with seized articles as mentioned above. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Sharada Pally, Shibmandir area.
