Sub: Complaint against my husband Sri Bipan Gurung and my mother in law
Smt Durga Gurung under Domestic Violence Act.

With due regards and humble submission , I Smt. Budhimaya Gurung @
Smt Priya Gurung, W/o Sri Bipan Gurung, R/o Betgara Dabgram, P.O -
Bhaktinagar, P.S - Bhaktinagar, Jalpaiguri, do hereby submit the following for
your kind information and necessary action :-

- 1 That I was married to Sri Bipan Gurung as a love marriage in the year 2012. Later on marriage was solemnized as per hindu rites and custom in presence of your family members and well wisher. After the marriage one daughter Miss Aroghi Gurung was born out of the said wed-lock.
- 2 That the first few days of the marriage were loving and cordial though there were always some misunderstandings and fights between us. However from the very first day of the marriage I realized that my husband was not behaving properly with me and my parents and was not respecting them. Later, I came to know that he is habitually play boy/womanizer. However, I ignored the same thinking that my husband would adjust himself further, as time went by my husband always found some or the other faults and argued and fought with me on trifle issues, with the support of my mother in law Smt. Durga Gurung.
- 3 Yet this aggrieved I did not make any complaint to anyone amongst his relatives and friends including well wisher about his ongoing traumatic and distressful physical, emotional, mental and cruelty and ongoing out of violence committed by my husband. As a time and again I tried to counsel my husband on this point in both the ways - lovingly and at times, sternly.
- 4 That after the marriage my husband physically abuse and tortured me by indulging in such an uncivilized behaviour every day for money. However with a view to maintain peace and continue a happy married life I decided not to argue or say anything wrong to him. I often faced financial crisis and immense hardship during my life time because my husband used to spent his earning money in Alcoholic and girls. Till last few months back there were no moral, financial and family support from my husband.
- 5 That even neighbours have seen to the daily acts of cruelty and torture perpetrated by my husband, situation has reach to such extend that one occasion even the neighbours intervene and advice her husband to stay peacefully and not to tortured her.
- 6 That my husband treated me like maid servant, and he never give to take prepare food sometime we were bound to survive with half food, and most of

the time he used to throw away the prepared/ cooked food my husband made it very difficult to survive us thus leads to cause serious weakness and now I am facing severe ailments like weakness, pressure and etc. My husband having his own hotel and doing land business and earning a handsome profit, whatever was earned by my husband was spent on the activity of gambling, drinking and on girls.

- 7 That even the house hold utensil, cloth, jewellery is sold by him on many occasion for his drinking purpose, which was taken by him without my knowledge, which indeed reflected his demeaning and highly irresponsible mentality against me. Months passed by and the happenings as stated hereinabove worsened by the day.
- 8 And on last month to the utter shock and surprise he was full drunk and beaten me badly in front of my minor daughter for which i obtain a serious injury in my chest and head. He even attack me with a sharp weapon but luckily I was escape. Even my mother in law has beaten me many times, she also told me beggars. They even threatened my minor daughter on many occasion during her exam times. And he has given threatening to kill us also.
- 9 That my husband and his mother often used to abuse me in a foul language, uncivilized words, languages, dictates, libel and slanders unheard of in a civil society. In fact, they expect son from me and after daughter was born they got fully upset for the same.
- 10 That now we completely felt insure with my husband because of their ill motive, violent and brutal in nature. I was made to sit in one corner of a room secluded, though living in my marital home i was feeling as if I have been confined to a shell of a prison having no right of freedom to step out of said marital house, of own will and aspiration.
- 11 And in this hardship days it is difficult for me and my children to meet day to day expenditure and the situation became totally unbearable, also no assets, no independent source of income & wholly dependent, and at present we are totally unsafe. And I am having multiple ailment for which I urgently require proper medical treatments, proper food and shelter. And in this hardship days it is difficult for me to meet day to day expenditure and the situation became totally unbearable and unsafe. Therefore, under the above situation they forced me leave the house, I was bound to leave my matrimonial house and now I am alone staying with my mother, but he didn't allow my daughter to stay with me. Despite the same i tried my best to go back my husband's house but they didn't allow me.

Under the above facts and circumstances you are hereby requested to lodge this Complaint under Domestic Violence Act and help me and my daughter and give us proper protection and security for which i shall be highly obliged.
