With due respect I, **SRI ASHOK KUMAR SHARMA**, Son of Sri Late Shyamlal Sharma, resident of A.M. Bose Road, Deshbandhupara, Post Office & Police Station Siliguri, District Darjeeling, the undersigned, would like to bring to your kind notice and state that I along with one **Sri Om Prakash Kumar**, Son of Sri Sudhir Kumar, resident of Manarbigaha, Post Office & Police Station Raniganj, District Gaya, Bihar entered into an a '**BAR, RESTAURANT MANAGEMENT AND OPERATIONS AGREEMENT**' dated **20.01.2022** with '**JAI MATA DI ENTERPRISES**', a Partnership firm represented by their partners (1) **Sri Ratan Kumar Singh**, Son of Sri Shyam Kumar Singh, resident of Gali No. 2, Sipahi Tola, Post Office & Police Station Khajanchihat, District Purnia, Bihar, (2) **Sri Gautam Kumar Singh**, Son of Arbind Prasad Singh, resident of Singhchitrabani, Road, Bhatta Bazaar, Post Office & Police Station Khajanchihat, District Purnia, Bihar, Pin - 854301, (3) **Sri Dipak Kumar Singh**, Son of Sri Shailandra Kumar Singh, Resident of Masdhubani, Post Office, Police Station & District Purnia, Bihar (4) **Sri Krishna Kumar Singh**, Son of Sri Krishna Kumar Singh, resident of Gali No. 2, Sipahi Tola, Post Office & Police Station Khajanchihat, District Purnia, Bihar, (5) **Sri Ravi Mukherjee**, Son of Sri Taraknath Mukherjee, resident of 2nd Mile, Sevoke Road, Post Office & Police Station Bhaktinagar, District Jalpaiguri.

In terms of the said Agreement Partners of said Jai Mata Di Enterprises, being the licensee of Department of Excise and Department of Health and Family Welfare to run a Bar and Restaurant and running a Bar com restaurant under the name and style of 'ANGEL BAR' granted management right of the said 'ANGEL BAR' to us as 'MANAGERS AND LICENSEES' at or for a monthly remuneration/License Fee of Rs. 3,75,000/- (Rupees Three Lacs Seventy-Five Thousand) only per month and on a security deposit of Rs. 15,00,000/- (Rupees Fifteen Lacs) only.

We had taken possession of the said Angel Bar and Restaurant on 30.11.2021 and had paid an amount of Rs. 17,21,098/- (Rupees Seventeen Lacs Twenty-One Thousand and Ninety-Eight) only to the partners of 'Jai Mata Di Enterprises' on various dates and started running the said 'Angel Bar and Restaurant'. The said Agreement was valid for one year, subject to yearly renewal.

On 23.01.2022 one **ANURUDH SHA** came to the said Angel Bar and Restaurant and took forcible possession of the said business in presence of Sri Ratan Singh, One of the Partners of said JAI MATA DI ENTERPRISES and the floor manager of ANGEL BAR AND RESTAURANT, Sri Mahesh Singh.

It could be ascertained that the said Anirudh Sha has got business relationship with the Partners of 'Angel Bar and Restaurant' and the said Anirudh Sha in collusion with the Partners of said JAI MATA DI ENTERPRISES have hatched up a conspiracy to cause wrongful loss to us.

That the partners of JAI MATA DI ENTERPRISES in collusion with the said Anirudh Sah have hatched up a conspiracy to cheat me and my associate for their illegal gain and have thus caused severe mental agony and pain to me and a loss of more than Rs. 20,00,000/- (Rupees Twenty Lacs) only and have also caused severe mental agony and pain to me.

I thereafter contacted with the partners of the said partnership Firm, namely 'Jai Matadi Enterprises', and there were several meeting being held with the partners of 'Jai Matadi Enterprises' but all such attempts made by me to amicably settle the dispute went in vein and having no other alternative I have approached your goodself for immediate redressal.

For such reason as aforesaid and also based on the assurances there has been some delay in lodging the complaint and the same may kindly be condoned.

I therefore pray before your goodself to investigate into the matter and take necessary action against the said persons namely **Sri Anurudh Sah** and the Partner of JAI MATA DI ENTERPRISES, namely **Sri Ratan Kumar Singh**, Son of Sri Shyam Kumar Singh, (2) **Sri Gautam Kumar Singh**, Son of Arbind Prasad Singh, (3) **Sri Dipak Kumar Singh**, Son of Sri Shailandra Kumar Singh, (4) **Sri Krishna Kumar Singh**, Son of Sri Krishna Kumar Singh, (5) **Sri Ravi Mukherjee**, Son of Sri Taraknath Mukherjee, and do the needful in this regard.
