Respected Sir,

I the undersigned would like to inform you that on 10-04-2022 at around 5.15 P.M. to 5.30 P.M., my father Lallan Kumar Singh, Son of Late. Yougeshwar Prasad Singh, resident of Nabarupa Apartment, Ananda Mohan Basu Road, Babupara, Siliguri-734004 was on his way for evening walk, near Alu Chowdhury More, Babupara, Siliguri and at that time a motorcycle, bearing Registration No. WB-74-AY-5346, which was driving in a rash and negligent manner and at a high speed, dashed with my father and as a result my father sustained severe bodily injuries.

Thereafter, my father was rushed to Desun Hospital, situated at Medical College Road, Siliguri-734012 for treatment but unfortunately he expired due to the injuries at around 8.45 P.M. on 10-04-2022. It is pertinent to mention that, we were preoccupied with the instant situation and as such was unable to lodge a written complaint on an earlier date.

Therefore, I request your goodself to take stern legal action against the driver of the aforesaid motorcycle who committed the accident and for which I shall remain ever grateful to you.
