Sir,

I, Prashanta Kumar Mahato, S/O Mr. Dilip Kumar Mahato, Assistant Engineer and Station Manager, Milanpally CCC do hereby lodge this complaint to the effect that today (12.04.2022 at 12:19 hours in pursuance of a secret information regarding theft of electric energy myself along with Sri Pranab Sikdar, SO, Darjeeling Region and other technical personnel had been to the spot at **Shyam Bihari Complex, Nayabazaar, Khalpara**, in the shop of **Mr. Anil Goyal, S/O M.P. Goyal**. After issuing notice to the representative of **Mr. Anil Goyal**, we check the departmental meter (No.: L4911533 and ID No: 401632724) found that his commercial connection was issued to him. Subsequently, due to non-payment of outstanding dues of Rs. 4,178 and as per WBERC from the date of disconnection 6 months was elapsed and therefore, the connection was declared as deemed disconnected on 12.04.2019.

On physical inspection, it has been detected that said **Mr. Anil Goyal** reconnected the line directly with the WBSEDCL service connection and **enjoying the electricity energy since 12.04.2019 unauthorised** without paying a furthering to this company in which the company is facing huge financial losses.

He did this intentionally, motivatedly with malafied intention for his wrongful gain.

As **Mr. Anil Goyal, S/O M.P. Goyal, Shyam Bihari Complex, Nayabazaar, Khalpara** has committed an offence, punishable under section 135(1) (a) and 138/1 (b) of Electricity Act, 2003. So, I, prepared inspection memo and seizure list by seizing the meter in presence of witnesses and supplied copies of it to the representatives of the premises owner. The existing load found is around 1.18 KVA and the final reading of meter is found 4631 kWh.

So, it is requested to start a case u/s 135(1)(a) and u/s 138(1)(b) of Electricity Act 2003 (Amendment Act 2007) against **Mr. Anil Goyal** and arrange for its investigation.
