Sir,

In producing herewith the following accused namely 1) Surajit Banerjee (37) @ Bara Bhim S/O. Atul Banerjee of Subhash Pally, Lichubagan, Ward No. 18, PS. SLG Dist. DJG. 2) Ratan Das (33) S/O. Tarun Das of Subhash pally, Lichubagan Ward No. 18, PS. SLG Dist. DJG., 3) Karan Das (30) S/O. Tarun Das of Subhash pally, Lichubagan Ward No. 18, PS. SLG Dist. DJG. 4) Utsab Shil (28) S/O. Jiban Shil of Bidhan Pally near Disun Hospital, Kawakhali, PS. Matigara Dist. Darjeeling in custody along with the following seized articles:-

- i) One Iron Made Sabot generally used for house breaking length approx 36" (inch) feet long from the Possession of Surajit Banerjee (37) @ Bara Bhim
- ii) ONE Ram daw (Chopper) made of iron with a wooden handle bar, total length approx 24" (inch) including handle from the possession of Ratan Das (33) S/O. Tarun Das.
- iii) One iron made chopper length approx 07 inch and butt approx 03 inch from the possession of Karan Das (30) S/O. Tarun Das.
- iv) One Iron Rod length about 04 feet seized from the possession of Utsab Shil (28) S/O. Jiban Shil.

I, S.I Diptajit Dhar of Siliguri P.S. SPC, would like to lodge this written complaint against the above noted persons and also 06/07 other unidentified persons to the effect that today i.e on 12/04/2022 at about 23.40 hours received a secret source information that a group of 06-07 persons has assembled at Bagrakote beside Bus stand with deadly weapons with a view to commit some heinous crime. Accordingly without waste any time I informed the matter to I/C Siliguri PS, and diarized the whole fact in Siliguri PS, GDE NO. 749, dtd. 12/04/22, due to lack of time and there was very chance of miss the information hence I did not obtained any search warrant, accordingly as per instruction of I/C Siliguri PS, I along with ASI Dhruba Mishra, ASI. Subir Sen, CV/283. Prasenjit Dey, CV/622. Ramanath Barm.in left PS to check out the veracity of the information and to work upon it. Vide this PS GDE NO. 750, Dt. 12/04/22 at 23.50 hrs.

We reached near the spot as directed by the source at about 00.15 hours dt. 13/04/2022 and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement. On way we tried to collect independent witnesses but due to late hours we could not able to get any independent witnesses. We reached at the Bagrakote behind Bus stand at about 00.25 hrs and found a group of 06/07 persons sitting at the darkest corner of bus stand. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 04 (Four) above referred

accused persons. After apprehension the 04 persons disclosed their identity as noted above and also stated that there were 06/07 other persons with them and they were un-identified and brought on hire. They were planning to commit a dacoity at the common people and vendors who returned home after completion of their daily business & work at Hawkers Corner and Mahabir sthan under Siliguri PS SPC.

This is to mentioned here that the said persons while started feeling away then they tried to cross the wall of the Tikiapara Bus Satnd they sustained injury on themselves. N.B : Accused 1) Surajit Banjerjee (37) @ Bara Bhim sustained injury on his left hand thumb finger; 2) Accused Ratan Das (33) S/O. Tarun Das sustained injury on his left leg and shoulder. Thereafter all the apprehended persons were searched in presence of the witnesses and the following articles were seized as noted above.

Thereafter all the articles were seized and labeled in-between 00.50 hrs to 01.15 hrs dt. 13/04/22 issuing a proper seizure list duly signed by the witnesses and the accused persons. Thereafter all the persons were arrested accordingly between 01.25 hrs to 01.45 hrs as they were assembled for committing heinous crime at the late hours at night.

On the above circumstances, I pray before you that a specific case U/S- 399/402 I.P.C. may kindly be started against the 04(Four) arrested persons namely 1) Surajit Banjerjee (37) @ Bara Bhim S/O. Atul Banerjee of Subhash pally Ward No. 18, PS. SLG Dist. DJG. 2) Ratan Das (33) S/O. Tarun Das of Subhash pally Ward No. 18, PS. SLG Dist. DJG., 3) Karan Das (30) S/O. Tarun Das of Subhash pally Ward No. 18, PS. SLG Dist. DJG. 4) Utsab Shil (28) S/O. Jiban Shil of Bidhan Pally near Disun Hospital, Kawakhali, PS. Matigara Dist. Darjeeling and 6/7 others unidentified persons for such assemble with deadly weapons to commit a heinous Crime.
