Respected Sir/ Madam,

I, the undersigned would like to draw your kind attention towards the fact that yesterday night at around 11:30 pm to 12:30 am, while me and my friends were waiting outside Hotel Mampi in my car bearing registration Number WB 74 BJ 6693 after ordering our food from the said hotel, when two miscreants who seemed to be in a drunken state suddenly came near our car and started pulling the steering wheel of my car and they even tried to enter into the car by opening the front door. When we tried to stop them they started abusing me and my friends by using filthy language. These miscreants also tried to pull me out of my car and molested me and touched my private parts inappropriately. Further, when the matter was intervened by my friends these miscreants pushed them and started throwing fists and blows towards them with an intention to injure them grievously.

These miscreants have also thrown bricks and stones with a motive to vandalize my car. They broke the front glass of my car. Not only did they damage my car but also looted one of my friend by taking away his money bag which had approx. Rs. 11,000/- (Rupees Eleven Thousand only) in it. After wrecking my car I heard one of the miscreants talking to the other and I strongly believe that this incident is highly motivated and influenced by any third person.
