Sub:- F.I.R. against my middle son Sri Pradip Paul and his wife Smt. Mampi Paul and my elder daughter namely Smt. Sumitra Guha for causing mental and physical torture upon me.

Respected Sir,

With due respect I, **SMT. ASHA PAUL**, Wife of Late Prabhu Ram Paul, Resident of Beside Paul Building, Opposite Bidhan Medicals, Bidhan Road, Hakim Para, P.O. & P.S. Siliguri, Dist. Darjeeling, Pin - 734001 and presently residing at C/O - Dhananjay Sharma, 276/1 Swamiji Sarani, Near Shanti More, Hakim Para, P.O. & P.S. Siliguri, District- Darjeeling, would like to lodge this written complaint to the effect that I am a 68 years of old aged widow lady and my husband Prabhu Ram Paul died intestate on 11.07.1984, leaving behind me, my three sons namely Bikash Paul, Pradip Paul, Kamal Paul and two daughters namely Smt. Sumitra Guha Paul and Suktara Paul as his only legal heirs and my three sons and elder daughter are married and my elder son and younger son are residing separately with their respective family members and my middle son Pradip Paul is residing at my own house. Sir, after the demise of my husband, I have acquired a plot of land measuring about 1 Katha, appertaining to and forming part of Plot No. 2253, recorded in Khatian No. 5484, within the Ward No. 12 S.M.C., P.O. & P.S. Siliguri, Dist. Darjeeling, by virtue of a Deed of Gift being Document No. 1-7203, for the year of 1989 and another Shop Room measuring about 248 Sq. Ft., appertaining to and forming part of Plot No. 2253, Recorded in Khatian No. 5484, and the same was acquired by virtue of another Deed of Gift, being Document No. 1-7849/7202, for the year of 1989 and both the Deeds were executed by my deceased father-in-law and after acquiring the aforesaid properties, I have constructed a two storied residential building in and over the aforesaid property as per the approved building plan and started to reside thereon along with my middle son Pradip Paul. Sir, since last few years, my said son has been creating tremendous pressure and torture upon me to transfer the ownership of the aforesaid property in his favour and after the death of my husband, the said torture has increased tremendously. Recently, i.e. on 22.09.2021 my son got married with one Smt. Mampi Paul and soon after his marriage, he in conspiracy with his wife have increased the parameter of the torture day by day and they have been harassing me by several means in order to grab the entire property and due to their continuous torture, when I assured them that I will divide and transfer the entire property amongst my all children including my younger daughter, they became furious and started to assault me and threatened to kill me though, they have no right title and interest in and over the aforesaid property. My son and his wife did not take any care upon me and denied to maintain me for a single day and out of the small earning from the said shop room, I have been maintain myself somehow and passing my remaining life with mercy of my younger daughter. Suddenly on 08.11.2021, my

son in conspiracy with his wife and my elder daughter, have created so many problems upon me to transfer the aforesaid properties in their favour and when I refused to do the same, they forcefully ousted me from my own house and threatened me not to enter in the house again and if I tried to enter into my own house, they will not hesitate to kill me and thereby, capture my entire property forcefully by illegal means and finding no other alternative, I have compelled to take shelter at the rented house of my younger daughter namely Smt. Suktara Paul at Raja Ram Mohan Roy Road, Ashram Para, P.O. & P.S. Siliguri, District- Darjeeling for some days and thereafter, we have shifted in another rented house at C/O - Dhananjay Sharma, 276/1 Swamiji Sarani, Near Shanti More, Hakimpura, P.O. & P.S. Siliguri, District- Darjeeling, with my younger daughter namely Smt. Suktara Paul and she is looking after and maintaining me as per her best efforts. Sir, my son and his wife along with my elder daughter have assaulted me on numerous occasions and they always abused me with filthy and abusive languages and they are always finding and searching for a chance of my death. Sir, I being an old aged widow woman, totally dependent upon the savings and small income from my said shop but presently, my son and his wife have forcefully captured my said shop and did not allow me to open the said shop room and on contrary, they have abused and threatened me with filthy and abusive languages and my son in conspiracy with his wife and my elder daughter have forced me to put my signature on some documents and papers without giving any opportunity to read out the contents of those documents and I have compelled to put my signatures under compulsion as per their direction. Sir, the above named persons are continuously causing mental and physical torture upon me on regular basis with an intention to harm me and grab my entire property and sometimes, my son and daughter-in-law have forced me to provide money as per their demand and by their such type of illegal acts, I had fallen ill and could not sleep throughout the night and my health condition is deteriorating day by day and I may not survive if immediate action will not take against the aforesaid persons as they are not allowing me to enter into the same house and use the said shop room and presently, they have forcefully occupied my aforesaid properties in their custody under lock and key.

I, therefore being a widow old aged lady, fervently requesting you to look into the matter properly and please take necessary steps against my son and his wife and my elder daughter for causing mental and physical torture upon me and also take proper steps to quit and vacate my premises and shop rooms occupied by my son and his wife illegally, so that I can pass my remaining life peacefully and obliged thereby.
