Respected Sir,

- I, Smt Jhuma Das, Wife of Late Jhantu Das, resident of Baghajatin Colony, P.O+P.S. Pradhan Nagar, Dist-Darjeeling, would like to report you the following facts:-
- 1. That one Pratima Darjee, W/O. Late P.B. Darjee, resident of Ganesh Bose Colony, Near State Guest House, Champadsari, Ward No. 46 of S.M.C. P.O+P.S. Pradhan Nagar, Dist- Darjeeling, who is well known to me came to me and requested me to lend her Rs. 4,00,000/- (Four Lacs) to her and on her repeated and constant request I gave her Rs. 4,00,000/- (Four Lacs) to her and an Agreement was executed to that effect between me and her and thereafter said Paratima Darjee in order to discharge her legal liability-issued an account payee cheque being No. 364573 of Axis Bank Ltd. to and in my favour but said cheque was returned dishonored and as such I gave her demand notice through lawyer to pay the aforesaid amount within 15 days.

2. That after receiving said demand notice said Pratima Darjee again requested me to give her some time for returning my aforesaid amount and promised that she would pay the aforesaid amount within 31.3.2022 in three installments and again an agreement was executed between her and me and she also issued three (3) Cheques being Cheque No. 560536 of Rs. 1,00,00,/-, 560537 of Rs 1,00,000/- and 560538 of Rs. 2,00,000/- of State Bank of India, Champasari Branch and told that on presentation of the aforesaid cheque the same would be honored, but said Pratima Darjee did not return a single penny to me during 31.3.2022, and so accordingly I presented the aforesaid three Cheque in my Bank for encashment but the same were returned dishonored.

Then and then I informed the aforesaid fact to said Pratima Darjee at that time she would come to my house and discuss the matter.

3. That today said Pratima Darjee came near my house and called me to meet outside of my house and when I went to meet her at that time she abused me and told that she would not return my aforesaid amount of Rs. 4,00,000/to me at any cost and threatened me by saying that if I claim the aforesaid amount from her or file any case against her in respect of the aforesaid cheque then she

would get murdered me and my daughter who live alone in the house as she is the local person of that area and has many contacts and no one can do anything of her.

4. That since beginning said Pratima Darjee had intention to cheat me and ultimately she deceived me and cheated my Rs. 4,00,000/- from me by constantly inducing me to pay the same to her. Had she not induced me I would not have given her the said amount.

I, therefore, request you to kindly take necessary legal action against said Pratima Darjee for cheating me and usurping my Rs.4,00,000/-.
