Pradhan Nagar, Dist - Darjeeling, West Bengal - 734003 would like to inform you that I have been working as Manager of Laxmi Lodge, and today i.e. on 13.04.2022 at about 12 P.M. while I was on my duty at Laxmi Lodge, some local Miscreants namely (1)Pankaj Saha, S/o. Ajit Saha, (2) Jhantu Saha, S/o. Late Jagendra Nath Saha, (3) Ajit Saha, S/o. Late Ramesh Ch. Saha, (4) Abhijit Saha, S/o. Ajit Saha, all are resident of Gurung Busty, P.O. Pradhan Nagar, Dist. Darjeeling and about 30 other unknown miscreants came to Laxmi Lodge and started to create nuisance in front of the lodge. When I raised protest they became violent and started to thrash me by fist and kicks.
