With due respect and humble submission, in producing herewith one accused namely Smt. Lily Gurung (45 years)W/o Sri Cham Bahadur Gurung of Salbari hat ,P.S-Pradhannagar,Dist. Darjeeling under arrest along with following articles under proper seizure ;

each bottle containing 600 ML

I SI Sibdhan Karmakar of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 14.04.22 at 13.05hrs in received a source information that one lady person namely Lily Gurung was storing and selling liquor illegally in her Petty shop at salbari hat .Accordingly I share the information with you and diarized the matter and as per your kind order myself along with force CV/128 Ajay Kr Sahani , CV/242 Rakesh Mangar & LC/ 1280 Bhakta Kumari Gurung left from PS vide PDN PS GDE NO .1060 dtd.14.04 .22 , After rush to the spot and as pointed by the source we apprehended the above noted lady person with the help of Lady constable and on search her shop ,recovered above noted articles , On demand she failed to produce any valid document in respect of recovered articles .On interrogation she admitted that she is selling the same illegally without obtaining valid document for her illegal gain. Accordingly, I seized & label the above noted articles in between 13.45 hrs to 14.15 hrs and I arrested her.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Smt. Lily Gurung (45 years)W/o Sri Cham Bahadur Gurung of Salbari hat ,P.S-Pradhannagar,Dist. Darjeeling and arrange for its investigation.
