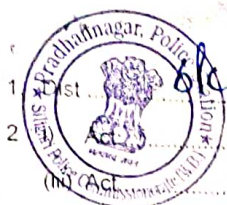

With due respect and humble submission, in producing herewith one accused namely Smt. Pranita Pradhan (35 years)W/o Sri Kishore Pradhan of Samrik Pani ,Top Line ,Pokharibong,P.s-Sukiapokhari,Dist. Darjeeling under arrest along with following articles under proper seizure ;

**i) 13(Thirteen) bottles of TUBORG Premium Beer ,each bottle containing 650 ML**

I SI Sibdhan Karmakar of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted lady accused person to the effect that today on 14.04.22 during raid duly at Salbari bazaar I received a source information that one lady persons has storing and selling liquor illegally in a Ranjana restaurant at Methabari under Pradhannagar PS . Accordingly I share the information with you over phone and as per your direction myself along with force CV/128 Ajay Kr Sahani , CV/242 Rakesh Mangar & LC/ 1280 Bhakta Kumari Gurung left for spot for Methabari vide PDN PS GDE No. 1060 dtd.14.04.22 , After rush to the spot and as pointed by the source we apprehended the above noted lady person with the help of Lady constable and on search her restaurant ,recovered above noted articles , On demand she failed to produce any valid document in respect of recovered articles .On interrogation she admitted that she is selling the same illegally without obtaining valid document for her illegal gain. Accordingly, I seized & label the above noted articles in between 15.25 hrs to 16.05 hrs and I arrested her.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Smt. Pranita Pradhan (35 years)W/o Sri Kishore Pradhan of Samrik Pani ,Top Line ,Pokharibong,P.s-Sukiapokhari,Dist. Darjeeling and arrange for its investigation.
