

Darjeeling, came to my shop to buy lottery, I said it's closed, he did not understand and became furious and angry, so he started using abusive language to me and my father and when I tried to object him, he assaulted me with an iron rod on my head and even he theft approx Rs. 10,000^(one thousand) from my cash. Then local people took me to the Civil Hospital for my treatment, at last he also threatened to kill me.
