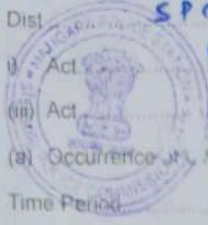

Subject: FIR

Sir,

In producing herewith one arrested accused person namely Rojesh Rai(37), S/O- Pushkar Rai of Sepoidhora, PO- Tindharia, PS- Kerseong, Dist-Darjeeling along with one seized vehicle bearing no- WB-73D1211 (Bolero Pick-Up) loaded with river bed materials under proper seizure.

I, PSI Rantu Haldar of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against one namely Rojesh Rai(37), S/O- Pushkar Rai of Sepoidhora, PO- Tindharia, PS- Kerseong, Dist-Darjeeling the driver of seized vehicle bearing no-WB-73D1211 (Bolero Pick-Up) loaded with river bed materials to the effect that today on 18.04.2022 at 16.15hrs. received a specific source information that one vehicle bearing no-WB-73D1211 (Bolero Pick-Up) loaded with river bed materials is about to move from the bank of Balasn River at Fulbari Patan area. Accordingly I informed the matter to the O/C PS and being directed by the O/C PS myself along with assisting force left PS to verify the veracity of source information. After reaching at the bank of Balasn River at Fulbari Patan area and being pointed by my source, I detained a vehicle bearing no-WB-73D1211 (Bolero Pick-Up) loaded with river bed materials on the bank of Balasn River at Fulbari Patan area under Matigara PS and also apprehended the driver of the said vehicle who on being asked disclosed his identity as Rojesh Rai(37), S/O- Pushkar Rai of Sepoidhora, PO- Tindharia, PS- Kerseong, Dist-Darjeeling. On demand he failed to produce any valid documents/papers for carrying the river bed materials. On being further interrogation the driver of the vehicle bearing no-WB-73D1211 (Bolero Pick-Up) stated that he, being directed by the owner of vehicle bearing WB- 73F2857(Tractor), is carrying river bed materials by illegal means for their wrongful gain since last few months. Accordingly I seized the vehicle bearing No WB-73D1211 (Bolero Pick-Up) being loaded with river bed materials and subsequently arrested the driver named Rojesh Rai(37), S/O- Pushkar Rai of Sepoidhora, PO- Tindharia, PS- Kerseong, Dist-Darjeeling. The whole process of seizure and arrest was made in between 17.55 hrs to 18.25hrs.

Hence, I pray that a specific case may kindly be started against the driver namely Rojesh Rai(37), S/O- Pushkar Rai of Sepoidhora, PO- Tindharia, PS- Kerseong, Dist-Darjeeling as well as the owner of the vehicle bearing No WB-73D1211 (Bolero Pick-Up) under proper section of Law and arrange for its investigation.
