SUB- FIRST INFORMATION REPORT

Respected Sir,

I, Smt. Jyotsna Saha, wife of Khokan Roy, resident of Indrapally, Near B. Ed College, Shivmandir, P.S- Matigara, Dist- Darjeeling inform you that I am an employee of Bharti Axa, an Insurance Company, situated at Sevoke Road, Siliguri, as a post of Yodha Officer (Sales and Marketing Officer), since the year 2021. In the Month of November 2021, in course of my business and work, I met with one Sri Shil Changia, son of Kamal Kumar Changia, resident of Embee Fortune Flat No. D. 5 A, Kadamtala, P.S- Matigara, Dist- Darjeeling through my friend, Sri Mohan Singh and the said Shil Changia introduced himself as a owner of Tea Garden and he showed and expressed his desireness to buy an Insurance from me of Bharti Axa. On being enquired by him, I informed him about some of good plans of the company. After fully satisfied with the benefits and terms and conditions of the policy, he purchased a policy of Life Insurance from

me of Bharti Axa. After purchase of the same he told me that he is a renowned businessman in the city and he has cordial relations with reputed businessman and several persons in the city of Siliguri. He further told me that he will help me in future for my Business and he will suggest/ refer his friends and relatives to purchase life Insurance from me to enhance my business and for my gain. I on good faith welcomed his gestured towards me.

Sir, after elapse of a month the said Shil Changia called me over my mobile and told me that one person of his contact is interested to purchase a life insurance and called me to meet him for further information of the policies. Accordingly, I went to his Office cum resident (as informed by him) at Embee Fortune, at Kadamtala, Near Durga Mandir, P.S. Matigara and discussed with the person introduced by him. After discussion, I left for my office.

After that day said Shil Changia started to call me occasionally and also started to sending me greetings messages. I always replied him as my customer in very good manner. Suddenly after few days he told me that my friend, Mohan Singh is also his good friend and he is planning for a outing on a weekend with him and requested me to join the same. Thereafter after discussion with my friend Mohan Singh, I agreed and we (Mohan Singh, myself and said Shil Changia) went for a outing on a weekend. During outing the said Shil Changia was very

numble and behaved like a gentleman. Thereafter a good friendship was developed between us. He started to call me frequently to discuss his business activities and even his problems of life. I always as a good friend talked with him. Subsequently, we (Mohan Singh, myself and said Shil Changia) again went for movies and for party in different occasions. Even he used to call me at his residence cum Office for introduction and meetings with several customers interested in life Insurance.

Sir, after few months, I notice that his behaviour were changing towards me and he had started to call me every day and even requesting me to meet at different restaurants in Siliguri which was not possible for me. Seeing the doubtful attitude, I started to avoid him and stopped to receive his phone calls. Thereafter he started to visit my office to meet me without any reason and its created very uncomfortable situations for me in my office. I several time told him to stop coming in my office but on the contrary he on many occasions chased me after my office while I was returning to my home.

I was very upset and disturbed with this behaviour of said Shil Changia and I warned him that I don't want to continue any friendship with him because of his ill behaviour. But again he started to doing the same things for the reason known to him and he was regularly requesting me to keep friendship with him very unlikely. Thereafter

finding no alternative I told him that I will lodge a written complaint against him then he told me not to lodge any complaint as he just want to keep friendship with me.

Sir, since last few days again the said Shil Changia is disturbing me which is causing mental harassment to me. On 19.03.2022 he called me over cell phone and told me that he will never disturb me but he want to meet me once as last time. On 21.03.2022 when I went to meet him he started to threatening me by pulling my hairs and he very illegally touched my waist by saying that i have to keep relationship with him and whenever he will ask me to come at his place I have to obey his orders. When I protested such illegal activities of the said Shil Changia then he told me that on 31.01.2022 he had captured my private/nude photograph while I was using his washroom of his resident cum office at EMBEE FORTUNE. He also told me that he has manufactured/tempered/edited my some photographs in wrong manner which he could upload on social media platforms if I will disclose this matter to anyone and disobey him. He showed me one edited photograph which was not very clear to me and threaten me that I will have to keep physical relationship with him otherwise he will upload this same on social media site and he will also send the photographs to my husband.

Sir, on 16.04.2022 the said Shil Changia has chased me while I was returning home and threaten me that if I will not keep physical relationship with him than I will have to face more dangerous consequences. He further told me that even he could kill me.

Sir I was in fear and kept myself mum to save my life and reputation but now he is regularly blackmailing me for illegal favour and has molested and threatened me with dire consequences.

Sir please help me and save my life from said Shil Changia by taking necessary legal action against him.
