
With due respect I Fulfuli Barman, resident of Paschim Dhantala, Fulbari Hat, would like to lodge an FIR by stating the following facts:

1. That my daughter namely Joba Barman was missing and a complaint in this regard had already been lodged by me Barman on 13<sup>th</sup> April, 2022 vide G.D.F. no. - 610.
2. That now new facts have emerged in connection with my missing daughter which needs to be investigated.
3. That my daughter Joba Barman was to be married very soon. She, in collusion with one Rajiv Sarkar@ Rajiv Mohammad, son of Khairul Mohammad of Belakova Bazar, Sonarbari, Dist. - Jalpaiguri, hatched a conspiracy to take away a huge sum of money kept for the purpose of marriage of my daughter Joba Barman.
4. That the said boy Rajiv Sarkar@ Rajiv Mohammad induced my daughter to run away with him by enticing her by different tectics. On 13/04/2022, he fled away with my daughter taking away 2,50,000/- (Two Lakhs Fifty Thousand) without our knowledge thus committing theft in collusion with each-other.
5. That that the amount was kept for the purpose of the marriage of my daughter which was obtained by selling some immovable property. It's a great loss of prestige as well as money to my family.

That when I along with my well wishers went to the house of boy namely Rajiv Mohammed and convinced my daughter to come back to me, she started weeping as if she was begging for help and agreed to come back without any hesitation. But the boy Rajiv Mohammed along with some local goons of the locality forcefully stopped my daughter and did not allow her to come back with me.
7. That the boy is very dangerous in attitude and nature and can traffic my daughter Joba Barman anytime, and take away all that money theft by them.

Therefore, I kindly request you to register my complaint and initiate immediate action to save my daughter and recover my money from being misused. And thereby I shall remain highly indebted to you.


