Sir,

I, Ms Swapna Tamang daughter of Sombir Tamang resident of Kalimpong, Sidim Kafer would like to complain as follows:

On 15/04/2022 I along with my sister Sanjeta Subba d/o Late Ujir Singh Subba in order to join our respective work places were crossing the road near Vishal Traffic crossing when the traffic lights were read for the vehicles and safe for pedestrians to cross the road. As we started to cross the road at that point a auto rickshaw bearing WB 71 A9697 violating the traffic signal, disobeying the red light hit both of us drastically and send flying only to crash land ON THE STREET. As a result of the said incident I sustained injuries on the head, dislocated right arm and right knee joint. I also suffered head injuries and lost consciousness for a while.

My sister suffered fracture on the right leg and arm and is suffering a lot. I don't know how we escaped the murderous assault on us by the said auto

I, therefore Sir, request you to initiate strong action against the said auto bearing registration number WB 71 A9697 and bring the miscreants to justice. As both of us were admitted in hospital we could not lodge he FIR earlier due our incapacity.
