Dear Sir,

I, Suman Sengupta, Divisional Engineer (E), Power House CCC, WBSSEDCL, Siliguri son of Sri. Ashoke Sengupta empowered by The Electricity Act 2003 amended on 2007 of India, do hereby lodge this written complaint against Sri **Alok Sharma (Secretary), Prestige Enclave, Shastri Nagar, Near Tiranga More (Cell-9832341137), P.S. - Bhaktinagar, Dist-Jalpaiguri**, to the effect that today on 19.04.2022 at about 13:00 Hrs. in pursuance of a tip off about unauthorized use of Electricity. Myself along with 1. Sanjay Prasad, Sr O.E, Power House CCC, 2) Sri Malay Goswami, D(E), S & LP, Darjeeling Regional Office, WBSSEDCL, and others supporting Officer & staffs had been to the spot at prestige Enclave, Shastri Nagar, P.S Bhaktinagar, Dist- Jalpaiguri.

After issuing notice, I inspected the meter having no. – SMR0333170129, Cons. Id. No. – 412032905. The connection is by the name of MAINAK NIRMAL PVT LTD, "PRESTIGE ENCLAVE", POLICE LINE, SHASTRI NAGAR, SEVOKE RD, SILIGURI. Prima Facie the meter is currently being used by the society of the apartment Prestige Enclave, the secretary of which is Sri Alok Sharma, as informed by the local residents, and the meter is being used for the domestic purpose of Common services of the building only.

On physical inspection it is found that, an extra line with a 4 Core, 3 Phase, Multi stranded, PVC Cable is going out from the main Busbar to some other Appliances for common use, bypassing the Common Energy Meter.

The Physical Load detected on site was 2Kw, that was being used in an unauthorized manner.

Accordingly I prepared inspection memo and seized the meter and service cable (being used for bypassing) after preparing a seizure list duly signed by a witness and Md Majid (representative of the secretary). We supplied copies of all documents to Md Majid (representative of the secretary **9832090622**).

We exited The premises at 14.10 hrs

So, you are requested that, a case under section **135(1) (b)** of Electricity Act 2003 amended on 2007 of India may please be registered against Sri **Alok Sharma** for knowingly using unauthorized supply of Electricity by Direct Hooking from the main busbar bypassing the common energy meter and arrange for its investigation.
