With due respect I Sri Ashim Saha, S/o. Sri Ananda Saha, resident of Dasarath Pally, P.O Sevoke Road, P.S Bhaktinagar, Dist. Jalpaiguri, would like to inform you that, I alongwith my younger sister Mousumi Saha and my father resides in my residential house and most of the time I alongwith my father stay in my shop room (Saha Medical Stores) situated at Dasarath Pally Bazar. Today at about 8.10 p.m. or 8.15 p.m. when one unknown person rang the door bell and at that my younger sister was alone and she just opened the gate suddenly said miscreant spread some chilli powder on the face of my sister and he also holding the throat of my sister and somehow she managed to escape from his hand and she started to shout on that time said miscreant kicked on the belly of my sister and he forcibly entered into my house and thereafter said miscreant forcibly taken most valuable things like wrist watch, my sister's mobile phone, my purse and one gold ring of my sister. Thereafter when I reached to my house I found his chappal on the entrance and after searching found the said miscreant is hiding on the top floor of my house just beside the water tanki by wearing a bed sheets. Thereafter local people caught him and on asking he disclosed his name Shraavan Sharma and I could gathered he was a carpenter some days before he made a centre table in my house and at the time of working. Thereafter I called the police and handed over him to the police personnel.

Under the above circumstances I would like to request you to investigate the matter and do needful according to the law for the ends of justice.
